1. CALL TO ORDER

4. DELEGATIONS

4.1 Phil Pothen, Ontario Environment Program Manager, Environmental Defence

Regarding the Land Needs Assessment and Intensification Analysis (Related to 5.2)

Phil Pothen, Ontario Environment Program Manager, Environmental Defence, expressed concerns on the approach used by the Region of Peel and its consultants regarding the Land Needs Assessment and Intensification Analysis. He requested that staff be directed to prepare and present an alternative option that maintains the current settlement area boundary.

Councillor Parrish requested that the delegate provide a summary of his speaking notes to the Committee.

4.2 Kathleen Wilson, Resident

Regarding Employment Area – Employment Land Jobs in Peel

Received

Kathleen Wilson, Resident, expressed concerns regarding the need to define hard urban boundary to stop sprawl; the defined needs for employment lands in the Region; food security; climate change; loss of agricultural lands; the future of work and education and the need to protect sensitive lands from development. Employment land needs cannot be appropriately addressed during the pandemic and must take into account future employment needs and not only for logistics warehouses. She requested that the Region of Peel pause its Official Plan review until the pandemic is resolved and, review its current planning practices to ensure future employment needs can be met.

4.3 Kate Hepworth, President, Caledon Village Association

Regarding Land Needs Assessment and Intensification Analysis (Related to 5.1, 5.2 and 6.3)

Received

Kate Hepworth, President, Caledon Village Association, stated that the Land Needs Assessment and Intensification Analysis cannot be properly addressed at this time due to COVID-19 restrictions and raised concern that Ontario loses approximately 175 acres of farmland per day. She requested that the Region of Peel pause its Official Plan review until the pandemic is resolved.

4.4 Jennifer LeForestier, Resident, Town of Caledon

Regarding Peel 2041+ Work Plan and Timeline Update and Land Needs Assessment and Intensification Analysis (Related to 5.1 and 5.2)

Received

Jennifer LeForestier, Resident, Town of Caledon, noted the importance of public consultation and engagement on planning matters such as planning for residential areas, natural heritage systems, preservation of existing farmland, watersheds and fixed urban boundary. She also expressed concerns about the impacts of aggregate extraction and urged comprehensive review of the cumulative impacts. She requested that the Region of Peel delay the Official Plan review until the pandemic is resolved, similar to recent decisions from the Region of Halton and the City of Hamilton.

Kathleen Moleski, Retiree, City of Mississauga, noted the importance of the preservation of the environment, climate change impacts, whitebelt and greenbelt areas; environmentally friendly neighbourhoods; and, the effectiveness of in person public consultation. She requested that the Region of Peel delay its

Official Plan review until the pandemic is resolved; provide new options for more intensified density targets to establish a fixed urban boundary; and, protect farmlands.

Sylvia Roberts, Resident, City of Brampton, expressed concerns with the housing and population forecasts used by the Region of Peel and its consultants. She noted the importance of the rapid housing needs in the City of Brampton, medium intensification in built up areas and transit needs.

Tara Buonpensiero, Manager, Integrated Planning and Virpal Kataure, Principal Planner, Regional Planning and Growth Management, provided an update regarding the proposed approach to accomplish the remaining Peel 2041+ work plan as it relates to recent Council decisions on the GTA West Transportation Corridor; anticipated timelines for the Official Plan Review and Municipal Comprehensive Review (MCR); an overview of past public consultations on environment and growth related focus area policies and Settlement Area Boundary Expansion (SABE) technical studies held in the fall of 2020; three focus areas (SABE, growth management and transportation) that are currently being reviewed to determine potential implications on Peel 2041+ should the GTA West highway not proceed; and, next steps.

Members of the Committee and other Regional Councillors present discussed and raised questions regarding: timelines and consultations with stakeholders and the public; status of the Major Transit Station Areas (MTSA) process; importance of the MTSA and inclusionary zoning as part of the Official Plan Review; active transportation study; goods movement; a potential oral update to Regional Council regarding the public consultation plan; population growth

targets; use of social media, newspaper, Councillor newsletters and other means to notify the public of future consultations; and status of aggregate resource policies.

Members of the Committee requested that the Chief Planner and Director of Regional Planning and Growth Management provide the following information at the next Planning and Growth Management Committee meeting:

- a summary of attendees and dates from the public consultations on environment and growth related focus area policies and Settlement Area Boundary Expansion (SABE) technical studies held in the spring and fall of 2020;
- staff's response to the matters raised by the delegates at the April 29, 2021 Committee meeting;
- an update regarding Official Plan Review public consultations to date; and,
- the positions of the City of Hamilton and the Region of Halton to delay their respective official plan reviews.

5.2 Land Needs Assessment and Intensification Analysis (Oral)

Presentation by Duran Wedderburn, Principal Planner, Regional Planning and Growth Management Division; and Paul Kulig, Principal, Perkins and Will

Received

Duran Wedderburn, Principal Planner, Regional Planning and Growth Management Division; and Paul Kulig, Principal, Perkins and Will, provided an overview of the methodology used for the land needs assessment and intensification analysis; preliminary findings related to community area land needs (population forecasts, housing need, allocation of housing need, housing supply potential by policy area, community area jobs and need for additional lands); preliminary findings regarding employment area (forecasts, allocation, existing employment area potential and the need for additional land); impacts of the COVID-19 pandemic on growth and development in Peel; and next steps.

Members of the Committee and other Regional Councillors present discussed and raised questions regarding: whether the projected 3,000 hectares of new community area land needs and 1,200 hectares of employment land needs was net of environmental features to be protected; strategic growth areas and Major Transit Station Areas (MTSA); infill and other opportunities that may arise in areas not identified in the intensification corridors; coordination with local municipal staff in identifying growth areas, urban and community nodes implementation planning; density targets; land use policies; and the importance of public and stakeholder consultation.

Councillor Thompson suggested that staff consider providing additional information on future reports, presentations or mappings regarding strategic growth areas and MTSA's overlaid with the planned transportation system to demonstrate how they feed into the employment and residential sectors.

Councillor Parrish requested that staff provide a breakdown of the projected allocation of single detached, semi-detached, townhouse and apartments for 2021 and 2051 by local municipality at the next Region of Peel Planning and Growth Management Committee meeting.

The Committee Clerk was requested to allocate three hours for future Planning and Growth Management Committee meetings.
