Please be advised that "Thapliyal Foundation Canada" (TFC) is a not-for-profit corporation/Organization that provides regular donations to SickKids Foundation and engages in charity work such as to organize Food Donation Drive, Fight against Hunger, Delivery of foods to our seniors and homeless people, Fundraising for cause of cancer with local community groups across the Greater Toronto Area.

On behalf of Thapliyal Foundation Canada, we would request you to initiate a requisition letter to build a New Hospital that is "**Children & Maternity Hospital**" in the Region of Peel area.

On December 23 and January 5, 2021, the GTA Hospital Incident Management System issued redirection of pediatric inpatients to SickKids Hospital in Toronto. As we enter a new year, hospitalization is surging across Ontario's province. In many of our communities across the Region of Peel and Greater Toronto Area, hospitals are stretched against the limits of capacity while families and front-line health care workers fight against the COVID-19 pandemic.

Hence, Thapliyal Foundation Canada hopes to enhance health care for children and pregnant females (Maternity) by advocating administrative authorities to build a new hospital that provides safe inpatient care for children and pregnant females in the Region of Peel. Health care needs in Ontario are growing along with its population. One of the basic needs families faces accessible, good quality health care and timely medical treatment.

Recently, parents have been concerned about travelling from Mississauga, Caledon, Brampton and other areas across the GTA to SickKids Hospital in Toronto. Some families have told us about the additional pressure of travelling to Toronto for their children's health care needs during emergency. On call 911 to get medical help for sickkids, Ambulance does not take sick kids to Sickkids Hospital but carry them to General Hospital due to its jurisdiction and admission issues.

Parents are forced to drive sick kids in personal vehicle from home to Toronto Sickkids Hospital where risk of children's life remain very high due to long travel time with long distance.

In the matter of pregnant females, the waiting time in General hospitals in Region of Peel is very high and due to long waiting time, there are several cases of miscarriages and stillborn children. Pregnant females need immediate help in order to save our children before their birth.

Thus, a pressing need in the Region of Peel Area is the need for a new designated "**Children & Maternity Hospital**". The official decision to go ahead with a new hospital rests with the provincial government and, in particular, with the Ministry of Health. It's time for decision-makers in government to hear that we need and deserve a new "**Children & Maternity Hospital**" in the Region of Peel.
