**RE: REQUEST FOR PUBLIC INFORMATION CENTRE REGARDING GREATER TORONTO  
AREA WEST MULTIMODAL TRANSPORTATION CORRIDOR**

I am writing to advise that at the Town Council meeting held on February 16, 2021, Council adopted a resolution requesting that the Ministry of Transportation (MTO) host a Public Information Centre (PIC) for Caledon residents to participate in regarding the Greater Toronto Area (GTA) West Multimodal Transportation Corridor.

Recently, the Town of Caledon has received comments and concerns from residents regarding the GTA West Transportation Corridor. We respectfully request that MTO host a PIC for the purpose of receiving and answering public questions and addressing concerns related to the GTA West Multimodal Transportation Corridor.

The resolution reads as follows:

*That the Mayor write a letter to the Honourable Caroline Mulroney, Minister of Transportation, requesting that the Ministry host a public information centre for Caledon residents for the purpose of receiving and answering public questions and addressing concerns related to the Province's confirmed GTA West Multimodal Transportation Corridor;*

*That the Mayor write a letter to the Honourable Justin Trudeau, Prime Minister, requesting that the Federal Government conduct an Environmental Impact Assessment of the proposed highway as has been done by Ecojustice Canada on behalf of Environmental Defence and the Town of Halton Hills;*

*And further that the Honourable Sylvia Jones, MPP, Dufferin Caledon and the Regional Municipality of Peel, be provided a copy this request.*
