Dear Minister Clark,

On behalf of the Region of Peel, I would like to thank you for the financial support provided during the past year as we continue to navigate through the COVID-19 pandemic. The provincial government's enhanced investment in housing and homelessness supports has been essential to our efforts to contain the spread of the virus in our community and there is an urgent need to continue this funding beyond March 31, 2021.

To date, the Region has received \$21.4 million in funding from the provincial Social Services Relief Fund (SSRF). Without this funding, the Region would not have been able to care for and protect the homeless and our community's most vulnerable throughout the pandemic.

As a result of these funds and funding from the federal government, our COVID-19 response for the homeless and other vulnerable populations has included:

- The use of hotels to reduce shelter occupancy to 50 per cent in order to create conditions for proper physical distancing
- Enhanced cleaning and other safety protocols for shelters
- Additional drop-in centres and supports for the homeless
- Isolation and Recovery Programs for the homeless and other vulnerable residents who either suspected they had the virus and needed a test and place to isolate, or those who contracted the virus and required medical care
- Flowing funds to over 60 community agencies that serve the vulnerable

Consequently, our COVID-19 response for the homeless has been very effective. In contrast to many other jurisdictions, the virus has largely been kept away from the shelter system. Its spread has also been broadly prevented amongst those homeless in Peel. Keeping families housed adequately and affordably has been an important factor in managing COVID-19.

Without these funding supports, COVID-19 outcomes would have been far worse in Peel. These current funding programs are set to expire by the end of March 2021. This is concerning as more transmissible variants of the virus have been identified in Ontario, and experts at the Province's Science Advisory Table have flagged the risk of a third wave before vaccinations are broadly available.
