Thank you for your application to the second intake of the *Audit and Accountability Fund* and for your commitment to delivering modern, efficient services that are financially sustainable.

I am pleased to inform you that the Government of Ontario will provide up to \$550,000 in funding for two projects under this intake of the *Audit and Accountability Fund*:

- Funding of up to \$250,000 towards the Region of Peel Development Planning and Engineering Service Review; and
- Funding of up to \$300,000 towards the Advancing Digital Service Delivery in the Region of Peel.

All funding is for the cost of an independent third-party reviewer to deliver a final report with specific and actionable recommendations for cost-savings and efficiencies by October 15, 2021.

In 2019, our government launched the *Audit and Accountability Fund* to help large urban municipalities improve local service delivery and ensure taxpayers' dollars are being used efficiently, and the impacts of the COVID-19 pandemic are making this work more important than ever. The projects selected for funding under the second intake of the *Audit and Accountability Fund* will further support your efforts to find efficiencies, with a focus on digital modernization, service integration and streamlining development approvals.

A transfer payment agreement is required to provide funding for this work. The ministry will forward a transfer payment agreement for this project for your municipality's review and signature in the coming days.
