


Intimate Partner Violence Reduction Strategy

Peel Regional Police Move into the Davis Centre

**In the month of May
598 charges were laid.**

The Top 5 charges:

- Assault (38%) - 204
- Utter Threats (10%) - 51
- Fail to Comply (9%) - 46
- Strangulation (7%) - 38
- Assault with a weapon (7%) – 37

***Note** the majority of the weapons used are knives and includes firearms.



**In one month there were 260 IPV
related occurrences.**

Referrals to Safe Centre of Peel


- **126 women** in the First three months of 2019/2020
- **331 women** in the first 3 months of 2021/2022

These numbers will increase as we transition out of the pandemic

We lack the resources to deliver our promise to women & children in Peel



Program Numbers & Outcomes



In 2019/2020 year
we served **506** clients

In 2021/2022 we anticipate
serving **1,324** clients

- **96%** of clients felt that they were connected to the services they needed
- **98%** of clients felt that staff were working together to help them
- **97%** of clients felt it was helpful to receive services in one location


