COVID-19 Situation Update

Strong public health measures and vaccination

Nine consecutive weeks of declining incidence

 As vaccination rates increase across Peel, residents are encouraged to get tested if they have mild symptoms of COVID-19 regardless of vaccination status or if they previously had COVID-19


- Need to be reminded to maintain caution
 - Increasing number of Delta cases in other areas of the province

Provincial Reopening Update

- Step 2 of Ontario's reopening plan began on June 30, 2021, which allows for the resumption of more outdoor activities and the reopening of some indoor spaces
- Ontario could move into Step 3 of Ontario's reopening plan on July 21 at the earliest, if targets are met
- Continued public health measures during reopening is necessary to minimize transmission risk
- Slow, steady reopening to:
 - monitor the impact of reopening
 - increase our second dose coverage

Vaccination Update

Percent of Peel residents who have received dose one only and dose two of COVID-19 vaccine as of July 5, 2021 at 12pm



77% of the population 12+ have received at least 1 dose of vaccine

42% of the population 12+ have received two doses of vaccine

65% of the population 12-17 have received at least one dose

 - General public




Coast to Coast challenge and Dusk 'til Dawn Events

Outdoors with people who are unvaccinated, partially vaccinated, or vaccination status is unknown



Indoors with people from who are unvaccinated, partially vaccinated, or vaccination status is unknown



Indoors or outdoors in a large crowd where people are closely gathering
