8.6 Jean Souliere, Chief Executive Officer, BusPatrol

Regarding the Peel Region School Bus Safety Program

Resolution Number 2021-849

Received

Jean Souliere, Chief Executive Officer, BusPatrol, provided an overview of the BusPatrol school bus safety program stating that the program takes a holistic safety-first approach which includes placing technology on every school bus in the communities they serve. The delegate stated that in addition to ticketing, the BusPatrol program can effectively contribute to planning routes more safely, training drivers and educating children and the public. The delegate stated that BusPatrol contractually commits to ensuring that no municipal partner is in a deficit and that 100 per cent of the costs to operate all aspects of the program are exclusively derived from fine revenue.

Members of Regional Council discussed and asked questions regarding: system installation (hardware technology) and operational costs; compliance with provincial legislation; the company known as Force Multiplier Solutions; a phased program with only external bus stop arm cameras; concerns regarding the extra

bundled technology; responsibility of the school boards versus municipalities; access and use of the proposed interior cameras and technology and the information/pictures they will gather; and, the Region of Peel's leadership role with respect to school bus safety in Ontario and the implications and benefits for BusPatrol.

The Commissioner of Public Works clarified that contracts negotiated to this point indicate municipal costs for technology may be covered by program revenues but local court costs (related to appeal rates) are not fully covered.

8.7 Nicole Cedrone, Parent

Regarding Safety in School Zones

Resolution Number 2021-850

Received

Nicole Cedrone, parent in the Region of Peel, spoke in support of the Automated School Bus Stop Arm Camera Program, stating that parents want to ensure students travelling by bus are safe; and, that arrival times are clear and communicated to parents. The delegate noted that cameras would protect bus drivers, provide safety for medical issues, help address student behavior and stop vehicles passing stopped school buses.

8.8 Tara Breeze

Regarding Support for the Automated School Bus Stop Arm Camera Program

Tara Breeze, spoke in support of additional measures to ensure student safety on buses; in particular, support of dash-camera technology that would capture information from vehicles that do not stop for school buses. The delegate noted driver behaviour has changed significantly in recent years and shared her personal experience of cars speeding and passing the school bus at her children's bus stop. She noted that home security camera footage is not sufficient for the purpose of police investigations and convictions.

8.9 Clarissa Lima-Randell, Resident, Region of Peel

Regarding Support for the Automated School Bus Stop Arm Camera Program

Resolution Number 2021-852

Received

Clarissa Lima-Randell, Resident, Region of Peel, spoke in support of the Automated School Bus Stop Arm Camera Program. The delegate noted that over 60,000 Peel Region students require home to school transportation, daily, and that according to provincial statistics, there are approximately 30,000 "blow-bys" every day. She provided an overview of existing provincial fines for drivers

passing school buses, noting that obstacles to enforcement include the need for a witness (e.g. the bus driver) to report the incident with vehicle information and to attend court. She requested that Regional Council make a decision to protect its constituents as soon as possible.

Members of Regional Council discussed and asked questions regarding: current constraints with respect to Ontario courts' inability to sign onto the program; potential hacking of interior bus cameras; implications of parents not consenting to video release; further provincial legislation requirements to incorporate the stop arm camera program into the Administrative Monetary Penalty System (AMPS) program; and, the ability to proceed with and complete convictions, without assistance of the police.

8.10 Wendy Dobson, General Manager, Student Transportation of Peel Region

Regarding the Benefits of the Automated School Bus Stop Arm Camera Program and the School Bus Safety Technology

Resolution Number 2021-853

Received

Wendy Dobson, General Manager, Student Transportation of Peel Region, spoke on behalf of the Peel District School Board, Dufferin Peel Catholic District School Board and Student Transportation of Peel Region (STOPR) in support of the Automated School Bus Stop Arm Camera Program and school bus safety technology. The delegate highlighted the benefits of the program including: external stop arm camera data collection; internal cameras that allow STOPR to monitor activity on school buses (e.g. medical matters, student misconduct, and bus driver concerns); connection to GPS which is linked to the parent application providing real time tracking and a visual map; and, the driver tablet application that provides directions to assist new and spare drivers to minimize delays and provide running routes (directly connected to the GPS and linked to the parent application). The delegate stated that the school boards and STOPR are pleased to partner with the Region of Peel and support and encourage the full implementation of the program as soon as possible.

Members of Regional Council discussed and asked questions regarding: implementation of the external stop arm cameras separately from the additional technology; school board versus municipal responsibilities with respect to student and school bus safety; interlinking of the external and internal technology components; and, the STOPR procurement process and due diligence with respect to BusPatrol.

8.12 Brad Butt, Member, Mississauga Traffic Safety Council

Regarding Support for the Automated School Bus Stop Arm Camera Program

7.1 Automated School Bus Stop Arm Camera – Program Implementation and Processing Centre Recommendations

(A position, plan, procedure, criteria or instruction to be applied to any negotiations carried on or to be carried on by or on behalf of the municipality or local board; and, advice that is subject to solicitor-client privilege, including communications necessary for that purpose)

The Regional Solicitor stated that the staff recommendation provided in the redacted report listed as item 7.1 on the July 8, 2021 Regional Council public agenda does not provide direction on whether or not to proceed with the Automated School Bus Stop Arm Program but proposes how to do so. The Regional Solicitor noted that local municipalities are responsible for maintaining the costs of the court system which may be impacted by the enforcement measures associated with this initiative; and, that Regional Council should consider whether the program will incur a deficit and whether the local municipalities will incur a financial loss when court costs are taken into account.

The Commissioner of Public Works stated that the staff recommendation in the subject report strives to ensure that the Stop Arm Camera Program is implemented in a legally and financially responsible manner. The Commissioner noted that staff have engaged Student Transportation of Peel Region (STOPR) as a program partner and continue to negotiate contract details with them. The Commissioner of Public Works provided an overview of a previous small scale stop arm pilot project conducted in Mississauga by Force Multiplier Solutions Canada and STOPR in 2016.

Members of Regional Council discussed and asked questions regarding: outstanding provincial legislation with respect to enforcement of infractions; enforcement capacity limitations with respect to the Ontario Provincial Police, Caledon Division, and Peel Regional Police; and, the need for provincial legislation to provide that appeals could be processed under the Administrative Monetary Penalty System (AMPS) program, outside of the court system.

And further, that in authorizing a Direct Negotiation with BusPatrol Inc., Regional Council hereby directs in accordance with section 3.1.1 of the Procurement By-law 30-2018, as amended, that the procurement be carried out in a manner other than in accordance with the provisions of the Procurement By-law, and confirms, in accordance with section 3.2.2 of the Procurement By-law, that it is satisfied that it is necessary to do so in the public interest in order to ensure an implementation timeline that supports public safety;

And further, that the Commissioner of Public Works be authorized to execute an agreement with BusPatrol Inc., the City of Brampton, the Town of Caledon, the City of Mississauga, and STOPR, represented by the Peel District School Board and the Dufferin Peel Catholic District School Board, and any related amendments and extensions thereto, for the enforcement technology and services necessary for the "Modified BusPatrol Program Model" that meets or exceeds current regulatory and legislative requirements, as well as for the technology and services necessary for STOPR's school bus modernization program, together with such further agreements and documents as deemed necessary or advisable for the implementation of and participation in the Automated School Bus Stop Arm Camera program as described in the subject in camera report, including the 'Automated School Bus Camera Agreement' with the Ministry of Transportation of Ontario, provided such agreements and documents are on business terms satisfactory to the Commissioner of Public Works and on legal terms satisfactory to the Regional Solicitor, and provided the program projects no net financial losses when considering the Region of Peel, the City of Brampton, the Town of Caledon, and the City of Mississauga;

Therefore be it resolved, that the “Modified BusPatrol Program Model” for a Peel Regional Automated School Bus Stop Arm Camera enforcement program, modified through negotiations where ticket revenues are used to fund enforcement program technology and services as well as school bus modernization technology and services, operated in a manner that ensures separation of public and private roles and responsibilities as required by law, scaled to match current and evolving existing Court capacity, addressing legal compliance and projecting no financial losses, and anticipating new contracts or amendments to existing contracts to align with forthcoming Administrative Monetary Penalties System legislation once in force, as outlined in the joint in camera report of the Commissioner of Public Works, the Chief Financial Officer and Commissioner of Corporate Services, and the Regional Solicitor, listed on the July 8, 2021 Regional Council in camera agenda, titled “Automated School Bus Stop Arm Camera – Program Implementation and Processing Centre Recommendations”, be endorsed;

And further, per the direction in Resolution 2020-867, that legal staff work directly with STOPR’s selected vendor, which has been identified as BusPatrol Inc., that the Chief Financial Officer and Commissioner of Corporate Services be authorized to award the Direct Negotiation to BusPatrol Inc. for the camera technology and services necessary to implement the “Modified BusPatrol Program Model for an Automated School Bus Stop Arm Camera program, as described in the subject in camera report, upon the successful completion of without prejudice negotiations;

And further, that in authorizing a Direct Negotiation with BusPatrol Inc., Regional Council hereby directs in accordance with section 3.1.1 of the Procurement By-law 30-2018, as amended, that the procurement be carried out in a manner other than in accordance with the provisions of the Procurement By-law, and confirms, in accordance with section 3.2.2 of the Procurement By-law, that it is satisfied that it is necessary to do so in the public interest in order to ensure an implementation timeline that supports public safety;

And further, that the Commissioner of Public Works be authorized to execute an agreement with BusPatrol Inc., the City of Brampton, the Town of Caledon, the City of Mississauga, and STOPR, represented by the Peel District School Board and the Dufferin Peel Catholic District School Board, and any related amendments and extensions thereto, for the enforcement technology and services necessary for the “Modified BusPatrol Program Model”, that meets or exceeds current regulatory and legislative requirements, as well as for the technology and services necessary for STOPR’s school bus modernization program, together with such further agreements and documents as deemed

necessary or advisable for the implementation of and participation in the Automated School Bus Stop Arm Camera program as described in the subject in camera report, including the 'Automated School Bus Camera Agreement' with the Ministry of Transportation of Ontario, provided such agreements and documents are on business terms satisfactory to the Commissioner of Public Works and on legal terms satisfactory to the Regional Solicitor, and provided the program projects no net financial losses when considering the Region of Peel, the City of Brampton, the Town of Caledon, and the City of Mississauga;

And further, that to reinforce Regional Council's requirement to ensure a cost neutral program, that it be a term of the agreement with Bus Patrol Inc. that in no case will the Region or any of the local municipalities incur any net financial losses in support of the Automated School Bus Stop Arm Camera program, including enforcement costs, court costs and non-enforcement technology costs;

And further, any agreement between STOPR and the Region or its lower tier partners, shall not bind the Region or participating Municipalities to any future costs for any other Safety features or elements on School Buses, not related and beyond the scope of the proposed "Modified Bus Patrol Program Model", as described in the subject in camera report;

And further, that the Commissioner of Public Works be delegated the authority to approve the financial and human resources needed to implement the "Modified BusPatrol Program Model" for an Automated School Bus Stop Arm Camera program as described in the subject in camera report;

And further, that the Commissioner of Public Works be delegated the authority to approve the financial resources needed to appropriately upgrade existing office space at a Region of Peel facility to the standard required for a preliminary Peel Regional Processing Centre, as required by the Ministry of Transportation of Ontario (MTO) for the execution of an 'Automated School Bus Camera Agreement' and access to license plate data in a timeline that anticipates MTO's pending updated certificate of offence and offence notice forms for the Highway Traffic Act section 175 (19.1) and (20.1) owner liability offences;

And further, that staff be directed to develop a formal business case in consultation with local municipalities in Peel Region ("local Municipalities") for a Peel Region Joint Processing Centre to serve municipalities outside of Peel Region and/or other automated enforcement programs under a future Administrative Monetary Penalties System, and that the Commissioner of Public Works be delegated authority to approve the financial and human resources needed to implement this direction as described in the subject in camera report;

Therefore be it resolved, that interim, emergency funding for the Safe Centre of Peel, in the amount of \$270,000, financed from the Tax Rate Stabilization Reserve, to the end of this fiscal year 2021, be approved to increase the capacity of its partner organizations to meet the growing demand for services as a result of the integration of the Peel Regional Police Intimate Partner Violence Unit and the COVID-19 pandemic;
