Progress in the Fight against COVID-19

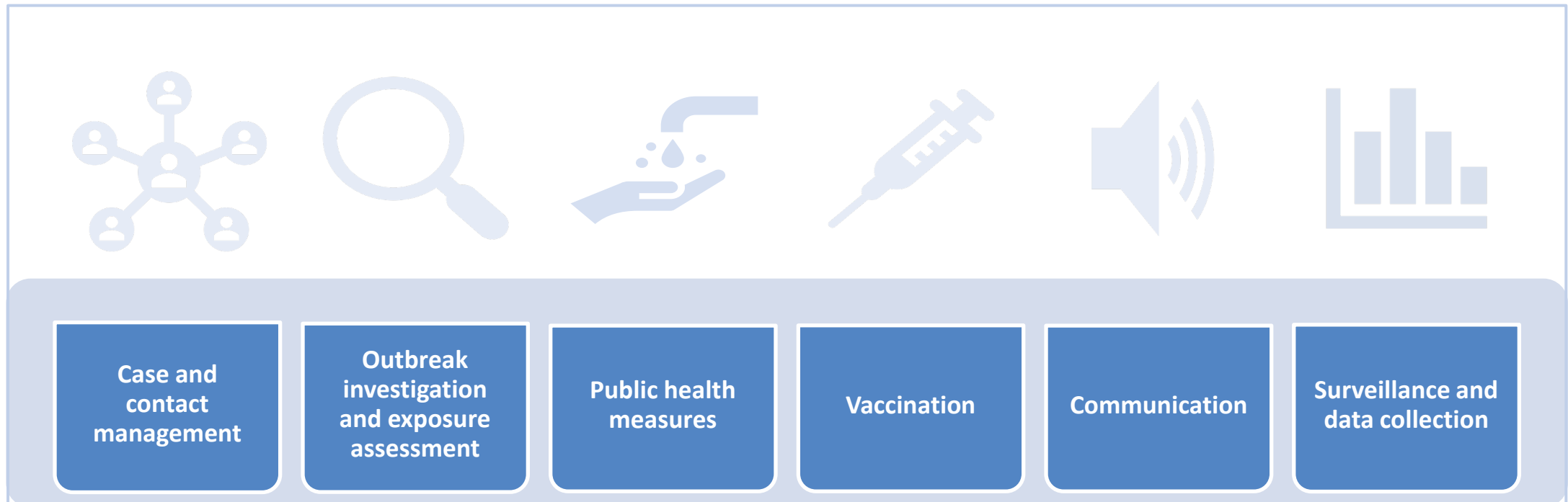
Over **100k** cases

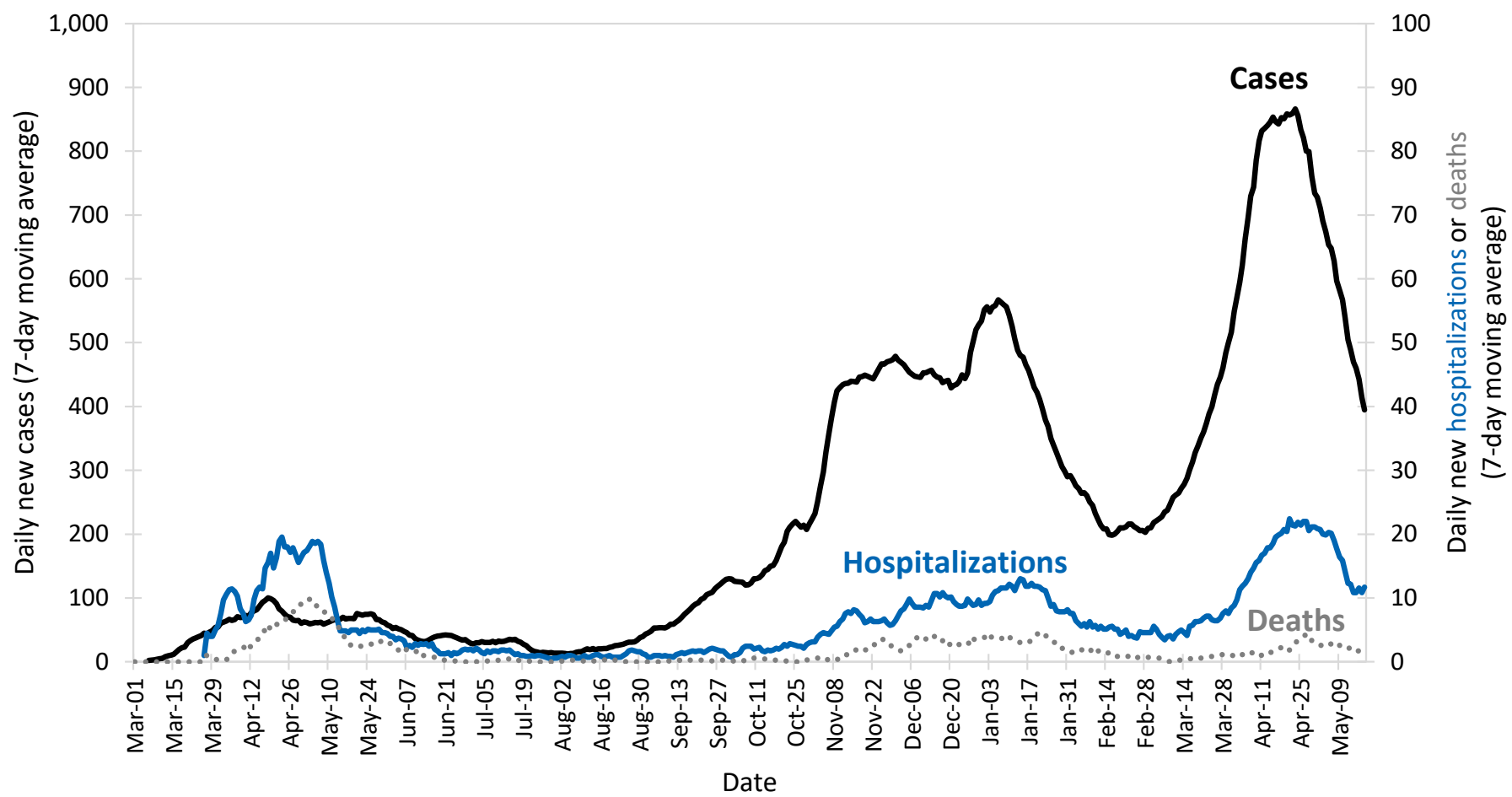

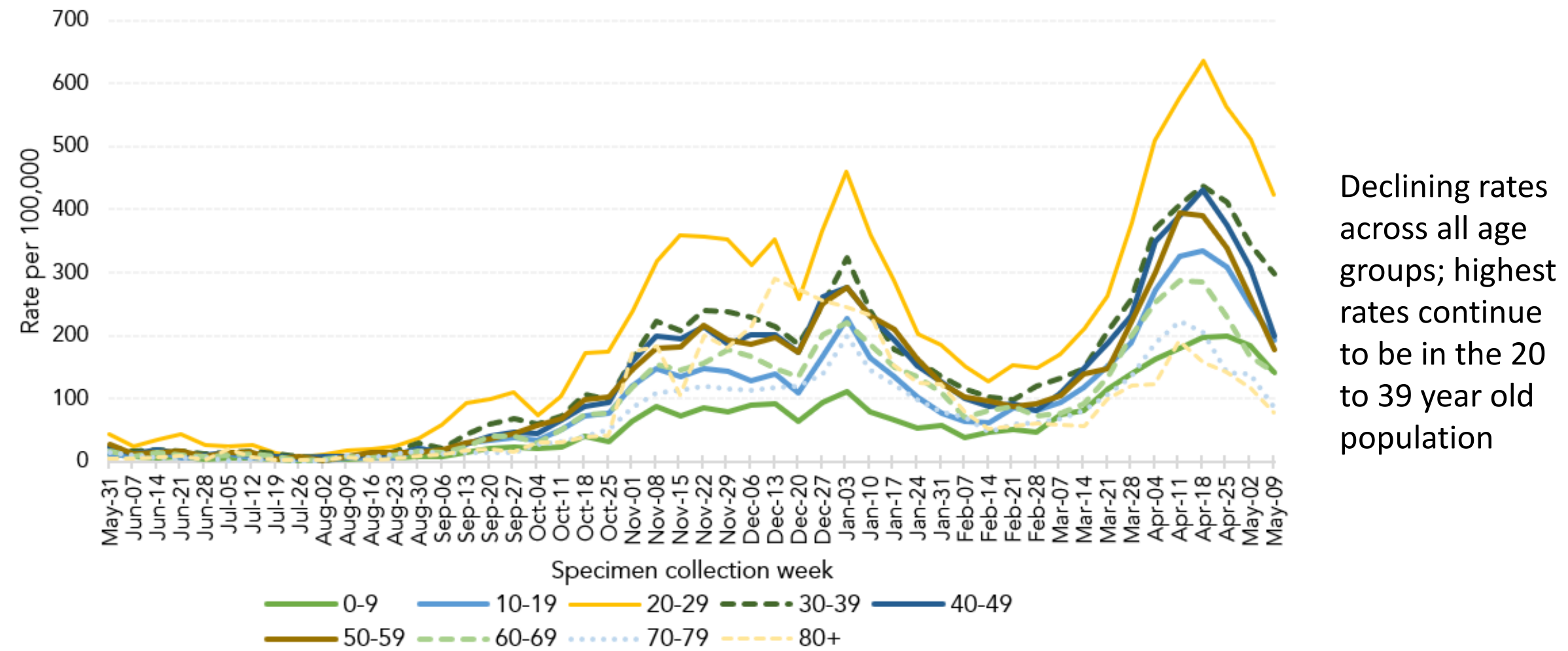

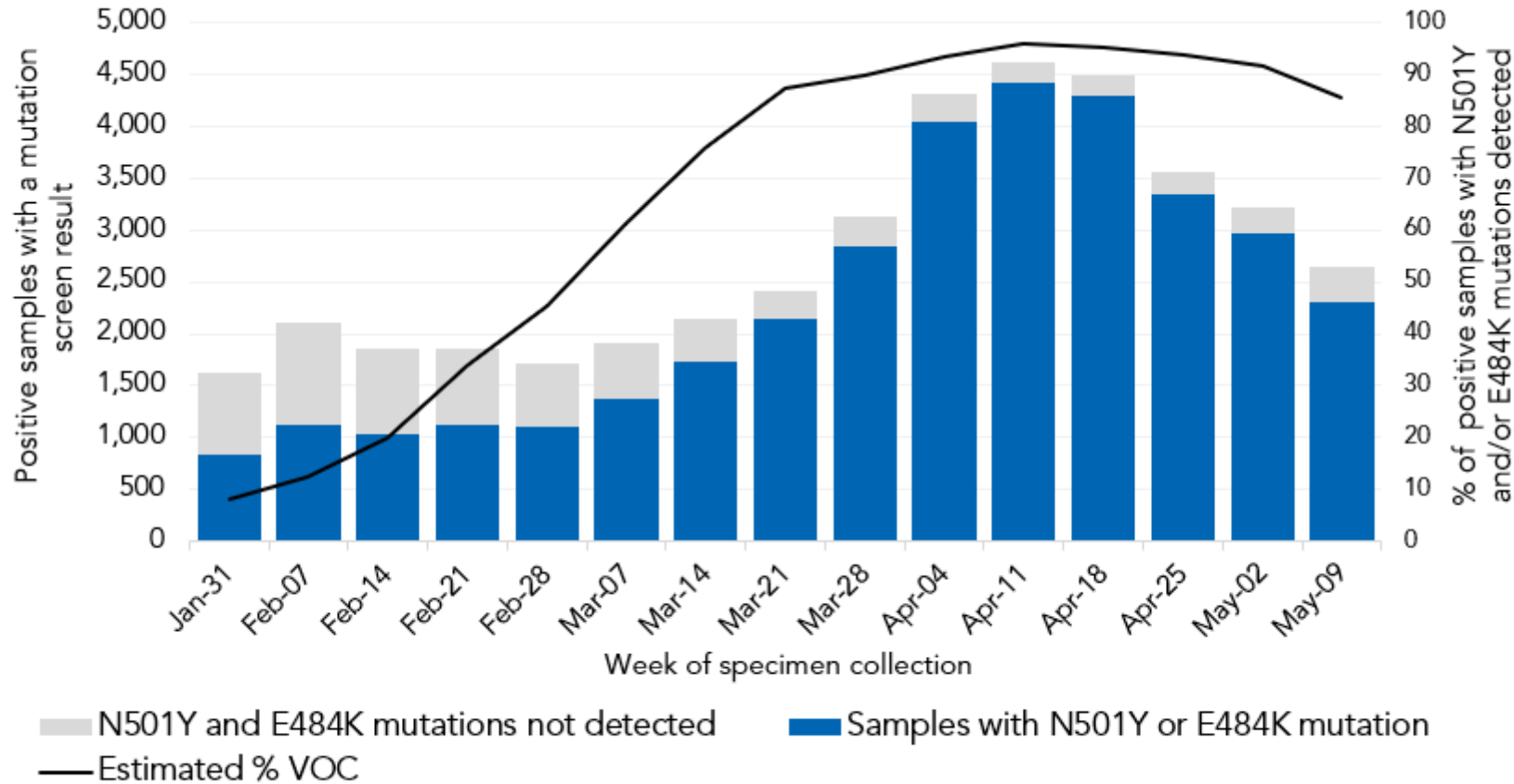

Age-specific COVID-19 Incidence Rates by 10-year Age Group, Peel

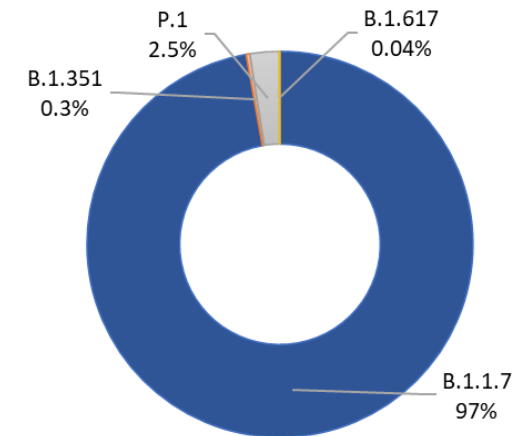

Provincial Reopening and Public Health Measures

Ontario's Roadmap to Reopen

- Province-wide three-step plan to gradually reopen
- Remain at each step for at least 21 days to assess vaccination rates and trends in other key public health and health system indicators (e.g., hospitalization, ICU, case rate, test percent positivity)
- Stage 1 expected to start the week of June 14, 2021

Peel preparedness:

- Recommended updates to municipal by-laws on face coverings
- Updates to the workplace Section 22 order

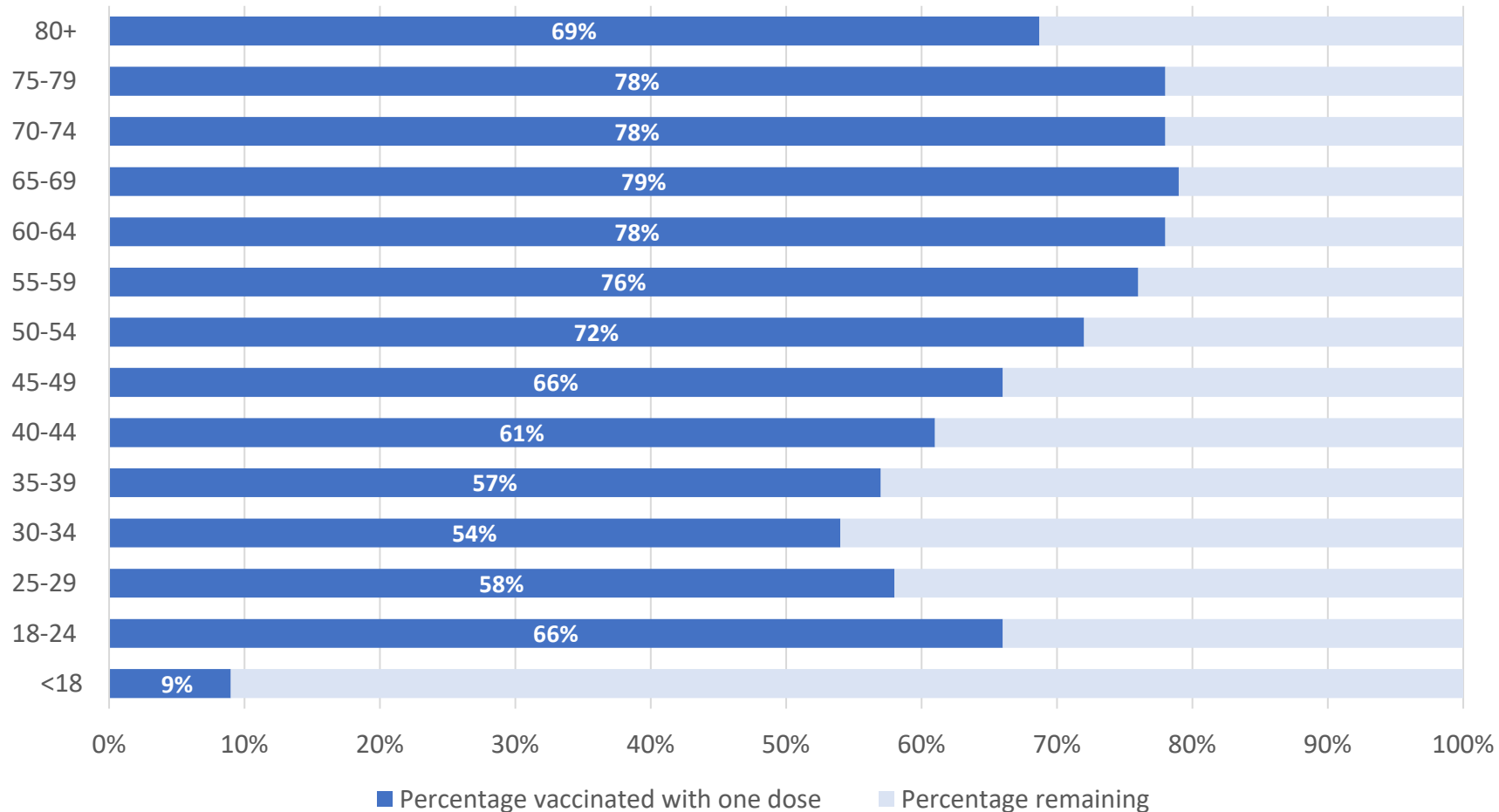

- 61% of those 18-49

Matching capacity to allocation.
Approach for June:

- Maintain **community clinics** to ensure reach and improve vaccine confidence
- Maintain **Primary Care and Pharmacy** channels as important vaccination options
- Adjust **fixed clinic capacity** as needed

*Exclusive of pharmacy channel ; **Arrived week of May 17;***Pfizer only confirmed at this time for June
PPH Allocation- total out of Peel allocation for Peel Public Health

Priorities Moving Forward

- Call to the public on civility and respect towards regional and municipal staff
- Adjust mass clinic capacity to limited Provincial supply
- Plan for second doses
- Increase focus on those with barriers to access and low vaccine confidence
- Follow needed public health measures as we plan for safe re-opening
- Key advocacy messages:
 - Lower allocations will substantially impact Peel's system capacity
 - Details on Province's second dose strategy are needed now
 - Hot spot approach is ideal, but at least per capita allocation of 10.7% is needed
