Dear Chair Iannicca and Mayor Crombie:

It was a pleasure meeting with you and your delegations at the 2021 Virtual Association of Municipalities of Ontario (AMO) Conference regarding the payments in-lieu of taxes (PILT) for the Greater Toronto Airports Authority and COVID-19 financial support for municipalities. I would also like to thank you, Mayor Crombie, for your recent letter providing further detail on these issues, including transit funding under the Safe Restart Agreement.

We truly appreciate the opportunity to hear from you about the issues that are important to your community. Please be assured, the Province understands the City and Region's concerns regarding the impact of reduced passenger volumes on the annual PILT payment, and in particular, implications that the five per cent cap on annual increases could have on the future PILT amounts paid by the Greater Toronto Airports Authority. I understand ministry staff recently held constructive discussions with city officials on this matter and are continuing to engage at the staff level. The government continues to consult on possible approaches to address this issue and appreciates your advice.

Since the onset of the pandemic, our government has focused on protecting people's health and the economy, as well as helping businesses and municipalities address critical challenges.
