

THE REGIONAL MUNICIPALITY OF PEEL

BY-LAW NUMBER 51-2021

**A by-law to amend By-law Number 15-2013 being
a by-law to regulate traffic on roads under the
jurisdiction of The Regional Municipality of Peel.**

WHEREAS, the Council of the Regional Corporation on the 24th day of January, 2013 passed By-law 15-2013 to consolidate the by-laws that regulate traffic on roads under the jurisdiction of The Regional Municipality of Peel;

AND WHEREAS, the Council of the Regional Municipality of Peel has by resolution passed on the 23rd day of September, 2021, authorized the enactment of a by-law to amend By-law 15-2013 effective October 15, 2021 with respect to removing Regional Road 6 (Embleton Road) from Schedule "A" of the subject by-law;

NOW THEREFORE, the Council of the Regional Corporation enacts as follows:

1. That Part 4 of Schedule A of By-law 15-2013 is amended by deleting the following:
