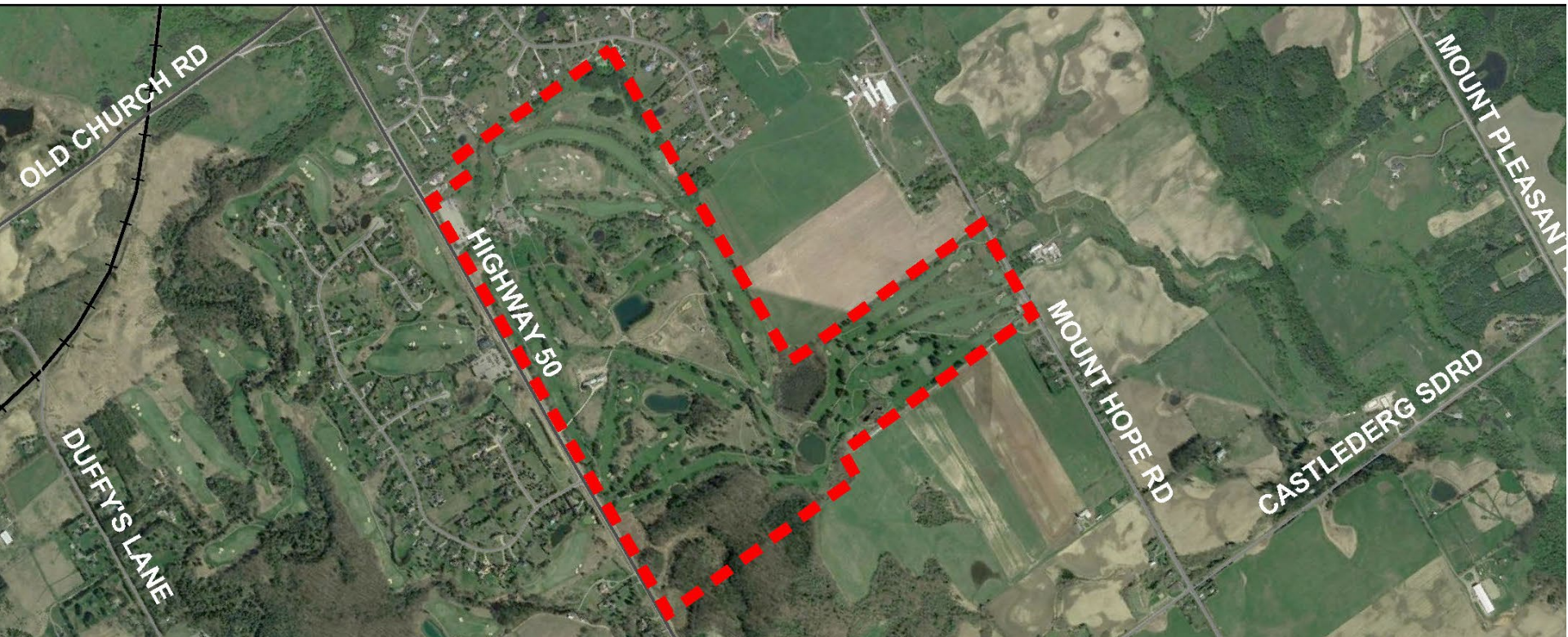

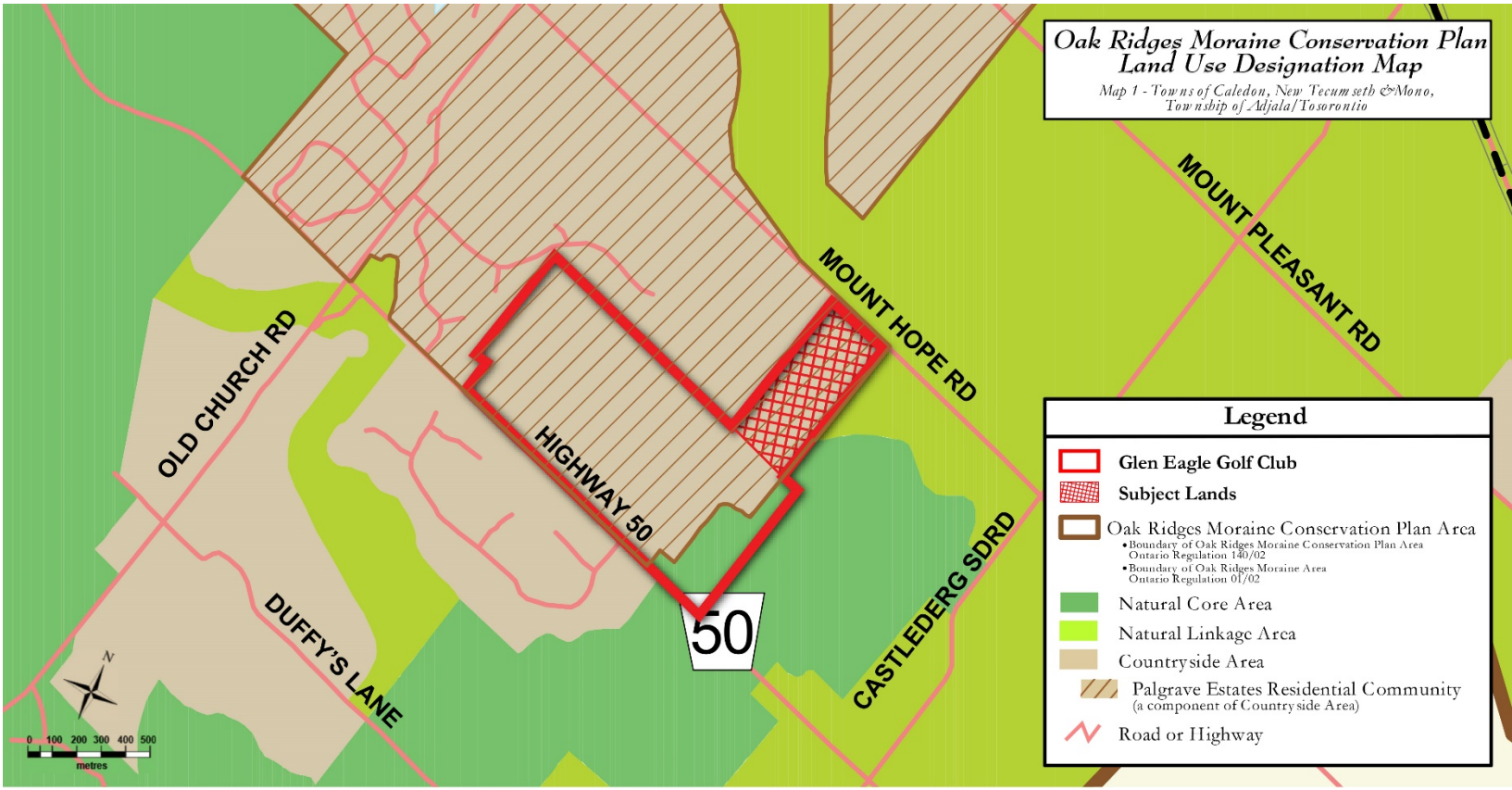

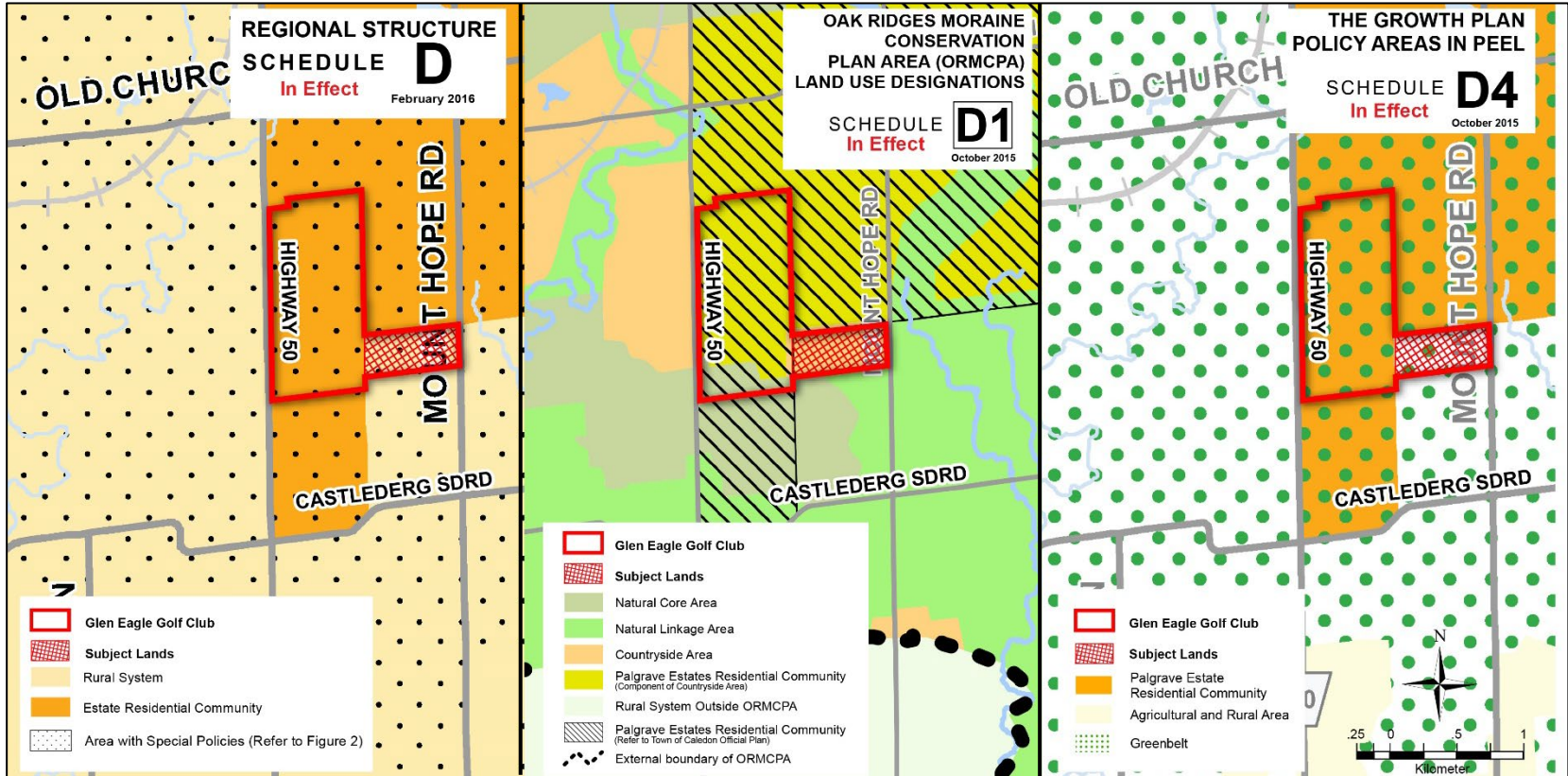

OUR REQUEST

That the Region of Peel refine the boundaries of the Palgrave Estate Residential Community on Schedule D, D1 and D4 of the Official Plan to reflect the boundary in the 2017 ORMCP through the Peel Region MCR process in order to conform to the ORMCP Act.
