On behalf of Region of Peel Council, thank you for meeting with our virtual delegation on August 17th at this year's AMO Conference. We appreciated the discussion on how we can work together on important issues, including waste infrastructure, single-use plastics and opportunities to advance a circular economy.

The Region of Peel was pleased to see the release of the final Blue Box regulation in June. This regulatory change has been a priority for municipal governments for over a decade and the Region looks forward to the transition from municipally operated programs to a producer-led Blue Box system.

As discussed in our meeting, with the anticipated growth of Peel communities, the amount of waste produced will also increase and we will work collaboratively with your ministry, and the provincial government as a whole, to meet this challenge. To that end, we were encouraged to hear during our meeting that the Province is committed to working with the federal government and the Canadian Council of Ministers of Environment on a plastics strategy.

As also discussed in our meeting, we look forward to working with your government toward the implementation of administrative monetary penalties (AMPs) under the Resource Recovery and Circular Economy Act. The AMPs regulation will be a key enforcement mechanism to ensure a level playing field for producers and other stakeholders and to ensure management targets and other regulatory requirements are met. We encourage your government to engage with the Region and other key stakeholders as policy changes to implement AMPs are being considered.

On behalf of the Region of Peel Council, thank you for meeting with our virtual delegation on August 16th during the recent AMO Conference to discuss several of the fiscal challenges we face in Peel, as well as ways we can continue working together to address housing and homelessness.

As we discussed during our meeting, Peel's Mass Vaccination Program is one of the largest and most expensive emergency initiatives that the Region and its partners have undertaken. Meeting the ongoing challenges associated with the COVID-19 pandemic has required extensive resources and unprecedented levels of cooperation from all levels of government and the Region appreciates the \$74 million in provincial support received to date.

We were encouraged to learn the Province will be soon be sharing more details about additional COVID-19 support for municipalities. As you know, we've made great strides safeguarding the health and well-being of residents, knowing that much more work lies ahead. As we noted during our discussion, we look forward to continued engagement with the Province in order to secure additional support to fully fund the balance of the \$154 million needed for the full 2021 year for this effort.

We also look forward to working with your government to address our concerns with the formula used to determine payment in-lieu-of taxes (PILT) on airport properties. With the significant decrease in passenger volume at Toronto Pearson International Airport due to the COVID-19 pandemic, there will be a significant decrease in PILT in 2022 – approximately \$9 million in lost revenue for the Region. As a result of the nature of the current policy, PILT will not return to 2021 levels until approximately 2056, which will result in a cumulative loss in revenue to the Region and City of Mississauga of almost \$750 million. Clearly, this is an important revenue stream for the Region, helping to ease pressures on property taxes and critical frontline services and we appreciate your commitment during our meeting to give this important issue further consideration.

We also remain committed to fully implementing Peel's Housing Master Plan, which will add more than 5,650 new affordable rental units in our communities. With limited revenue tools, the Region's affordable and supportive housing goals can only be achieved if we continue to receive sufficient capital and operating funding from our federal and provincial partners, and specifically, we need the support of the Province

to fund the remaining \$319.7 million to advance the community's affordable housing needs in Peel.

Considering the issues above, it is clear that we are facing significant financial challenges and, like many other municipalities across Ontario, Peel is increasingly doing more with less. Without sustainable funding tools, the Region does not have the financial resources to maintain and build the necessary infrastructure and provide the appropriate level of services to support Peel's growth. As we discussed during our meeting, the Region is committed to ongoing engagement and collaboration with you, and we welcome the opportunity to explore how we can modernize revenue tools to ensure that we can avoid overburdening the municipal property tax base.

Having received A-rating decades ago, the Seniors Health and Wellness Village at Peel Manor in Brampton is not eligible for redevelopment funding and we would like to work with you, and all of our provincial partners, to secure capital and operational funding to support the rebuilding and transformation of this facility.

On behalf of Region of Peel Council, thank you for meeting with our virtual delegation on August 17th at the recent AMO Conference.

We appreciate the steps the provincial government has taken to protect vulnerable seniors during the COVID-19 pandemic. As we discussed with you during our meeting, the Region remains dedicated to providing emotionally focused care through the Butterfly Home model, which uses a person-centred approach to successfully address clinical needs, protect the health and safety of residents and improve the well-being of those living with dementia.

As noted, in the attached briefing note, the Region welcomes the opportunity for further engagement with the Province to support seniors and address the Region's system capacity challenges, including the following:

- Funding enhancements to support staffing and training needs to support emotion-based care and enhance care in the community
- Provincial standards for integrated, emotion-based care
- Mandates that standardize emotional well-being
- Legislation and measurement tools that enable emotion-based cared Model
- Capital and sustainable operational funding for the Seniors Health and Wellness
 Village at Peel Manor

We appreciate the interest you expressed during our meeting in learning more about the leading working being undertaken in Peel and our efforts to implement the Butterfly model of care across our five long-term care homes. This model of care includes empowering staff to know the people in their care, and take every opportunity to engage them in personal, meaningful ways, while also creating a home-like environment with dementia friendly design. The Region believes emotion-based care models, like the Butterfly model, are foundational to long-term care modernization. Emotion-based care shifts the way in which care is provided, from being task-oriented to truly put the person at the centre of care and focus on their overall wellbeing in addition to their clinical needs.

As we discussed during our meeting, we would like to invite you to tour our Malton Village long-term care home, where we have successfully implemented a Butterfly Home program. Other visitors have found that seeing our work in action helps inform

The rapid growth of the aging population creates increasing pressures across the seniors' services sector at all levels of government and increased investment in existing LTC beds and community support services will help offset these pressures. We were encouraged by our discussion about further consideration being given to the provincial rating system of LTC beds. Having received an A-rating decades ago, Peel Manor is not eligible for redevelopment funding and we would like to continue working with you and your ministry to secure critical provincial support for the rebuilding and transformation of this facility as well as sustainable operational funding to expand community support services at Peel Manor.

The Region appreciates your commitment to begin deploying funding this year to achieve the 4 hours of care standard. Your acknowledgment of the pressures that exist in Peel was also encouraging and we urge you to allocate this funding expeditiously and equitably.

On behalf of Region of Peel Council, thank you for meeting with our virtual delegation on August 16th at the recent AMO Conference. As the provincial representative of a high-growth community, you understand the pressures and challenges facing Peel and its communities of Mississauga, Brampton and Caledon and we are encouraged by the steps that the provincial government has taken to expedite priority transportation projects in Peel, and throughout Ontario.

On behalf of Region of Peel Council, thank you for meeting with the Region's virtual delegation on August 17th at this year's AMO Conference. We valued the productive discussion about support for long-term growth and the Canada-Ontario Bilateral Agreement.

The Region and the Province have a successful track record of working together and we appreciated the discussion on the importance of flowing critical infrastructure funding to municipalities. As mentioned during our meeting, by working together at all levels of government, we can advance critical municipal infrastructure in order to hasten a strong economic recovery in Peel and throughout Ontario.

Investing in infrastructure is good for the economy and will be a critical component of our post-pandemic planning. According to the report Benefits and Risks of Growth: Region of Peel Costs from the Canadian Centre for Economic Analysis, for every dollar increase of GDP in Peel, provincial GDP increases by \$1.63. For every dollar of municipal revenue in Peel due to growth, provincial revenues increase by \$5.70.

Municipalities however, face challenges in building such infrastructure and need the support of the provincial and federal governments, which includes increased, predictable and sustainable infrastructure funding. Investments in infrastructure will also help the Region to meet the anticipated growth and the long-term needs of Peel's residents and businesses.

We were encouraged that the Province is engaged with the federal government to ensure timeline extensions are finalized through an update to the Canada-Ontario Bilateral Agreement. Earlier this year, an additional \$18.7 million in funding was announced under the Investing in Canadian Infrastructure Program's COVID-19 Infrastructure Resiliency Stream. The Region not only appreciates this additional funding, but also particularly how it is being distributed through an allocation funding model.

An allocation funding model better meets the needs of the municipal sector as it provides timeframes that correspond to a realistic infrastructure planning and implementation cycle. While we see the use of the allocation funding model for the COVID-19 Infrastructure Resiliency Stream as positive progress, we encourage the



Province to modernize additional funding processes so investments can get out more quickly to kick start Ontario's economy.

On behalf of Region of Peel Council, thank you for meeting with our virtual delegation on August 16th at the recent AMO Conference. We valued the productive discussion about some of the key opportunities, as well as some of the challenges that exist in Peel.

Like many other municipalities across Ontario, Peel Region is increasingly doing more with less. Without sustainable funding tools, the Region does not have the financial resources to maintain and build the necessary infrastructure and provide the appropriate level of services to support Peel's growth. The Region is committed to ongoing engagement and collaboration with you, and elected officials at all levels of government, so that we can be effective partners as Ontario recovers and rebuilds from the pandemic.

As we discussed during our meeting, Peel's Mass Vaccination Program is one of the largest and most expensive emergency initiatives the Region and its partners have undertaken. As you know, we've made great strides to safeguard the health and well-being of residents, knowing that much more work lies ahead. While we appreciate the \$74 million in support received so far, we are seeking additional support to fund the balance of the \$154 million needed for the full 2021 year for this effort and adding your voice to our advocacy efforts is greatly appreciated.

Our delegation was also pleased to discuss with you our shared priority to protect and support vulnerable seniors. The rapid growth of the aging population creates increasing pressures across the seniors' services sector at all levels of government and increased investment in existing long-term care beds and community services will help offset these pressures.

We believe it's important for the provincial government to invest in exist long-term care beds, and we are urging the Province to consider challenges associated with the rating system of these beds. Having received A-rating decades ago, the Seniors Health and Wellness Village at Peel Manor in Brampton is not eligible for redevelopment funding and we would like to work with you, and all of our provincial partners, to secure capital and operational funding to support the rebuilding and transformation of this facility.

With the significant decrease in passenger volume at Toronto Pearson International Airport due to the COVID-19 pandemic, there will be a significant decrease in PILT in 2022 – approximately \$9 million in lost revenue for the Region. As a result of the nature of the current policy, PILT will not return to 2021 levels until approximately 2056, which will result in a cumulative loss in revenue to the Region and City of Mississauga of almost \$750 million. Clearly, this is an important revenue stream for the Region, helping to ease pressures on property taxes and critical frontline services and we would appreciate your support to advocate for an update to the PILT regime on airport properties in order to reflect current realities.
