The Region of Peel has been committed to meeting conformance with the World Wide Web Consortium Web Content Accessibility Guidelines 2.0 Level AA and its January 1, 2021 deadline. Time, effort and resources have been invested into meeting the requirements but unfortunately, a number of setbacks, including the immediate response to the pandemic, have delayed our timelines. The work is ongoing. There are a number of sites in our Peelregion.ca website and social media pages that we are updating to ensure conformance and can confidently say that we are making strides and progress. Overall status of website compliance is 64%. for which we estimate that by December 31, 2022, all sections will be 100% compliant (not including Health Services). However, we must point out that any claim to compliance is a snapshot in time as a slight error in any of our websites or apps would lead to non-compliance. The Region of Peel is committed to increasing accessibility for persons with disabilities and is of the mindset that accessibility goes beyond adhering to the requirements of the standard and involves a number of ongoing approaches that the Region is undertaking, including improvements to the end-user experience, manual checks and testing, the introduction of a web accessibility policy, updates to our processes, ongoing training and education, to name a few. It is for the reasons stated that we have responded "no" on this report.
