OBJECTIVE

To provide an update on the activities undertaken by the Region of Peel Accessibility Planning Program and the Accessibility Advisory Committee, subsequent to the February 17, 2022 Accessibility Advisory Committee meeting.

REPORT HIGHLIGHTS

- The Accessibility Advisory Committee and Accessibility Planning Program have been involved in various activities during this period, which are categorized as follows:
 - o Consultation and compliance support provided to Regional Programs; and
 - Upcoming events and observances.

DISCUSSION

1. Background

The objective of the Region of Peel's Accessibility Planning Program (the Program) is to ensure that Regional programs, services and facilities continue to be inclusive and accessible for persons with disabilities. In order to accomplish this objective, the Program works collaboratively with all Regional departments and the Region of Peel Accessibility Advisory Committee (AAC).

2. Activity List

a) Consultation and Compliance

i) Accessibility at Peel Intranet Hub

- On February 15, Peel launched Accessibility Peel, the Region's intranet accessibility hub for staff.
- The site offers a one stop shop for all things accessibility in Peel and offers related information, policies and resources.

ii) 2021 Annual Accessibility Status Report

 As required under the Accessibility for Ontarians with Disabilities Act, internal departments have been consulted on their accessibility accomplishment and initiatives for 2021.

iii) Age-Friendly Planning Project

- Seniors represent one of the fastest growing age groups in the Region of Peel.
- Accessibility is a key consideration as we plan for our growing aging population.
- To prepare for this growing demographic, new policies related to health, the built environment and age-friendly planning have been adopted as part of the Regional Official Plan Amendment (ROPA) 27.
- Part of this work includes an Age-friendly Built Environment Assessment which will assist the Region to evaluate the current-state of neighbourhoods with regards to age-friendly built environments.

iv) Metrolinx Accessibility Virtual Open House

- On March 2, 2022, Metrolinx hosted its Accessibility Virtual Open House.
- Objectives of the open house:
 - o To provide an update on accessibility achievements,
 - o To share information on key planned initiatives for next year,
 - Seek feedback to ensure services and projects reflect the community's needs, and
 - Provide an opportunity for input into their accessibility planning efforts.

i) Ability Summit
