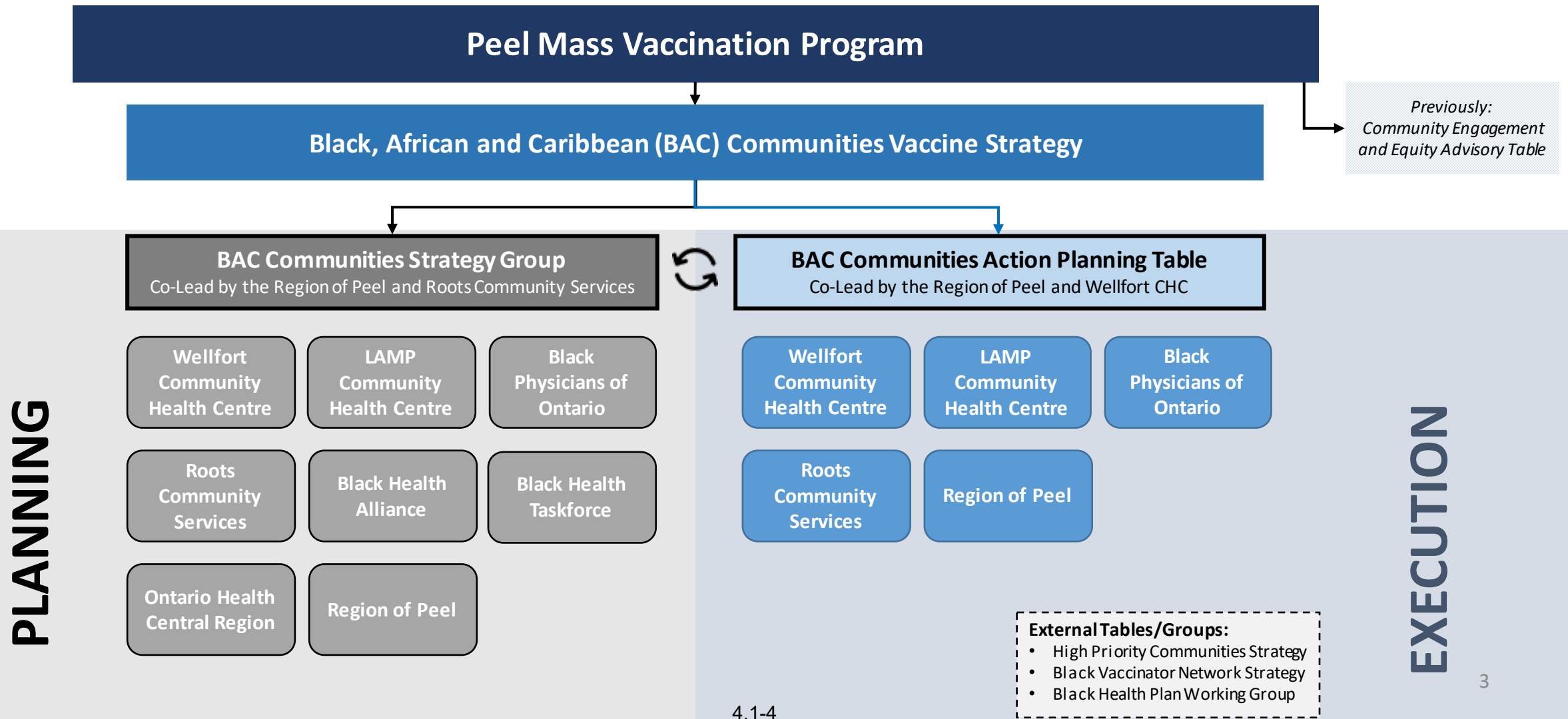

# What COVID-19 has revealed

- Racialized health inequities have been factors in the lives of Ontario's Black population for a long time
- The impact of longstanding systemic discrimination and historical mistrust of government and the health system underlies the inequities experienced by this population
- Between June-December 2021, COVID-19 cases among Black people accounted for 18.5% of the total cases despite only representing 9.5% of the total population in Peel

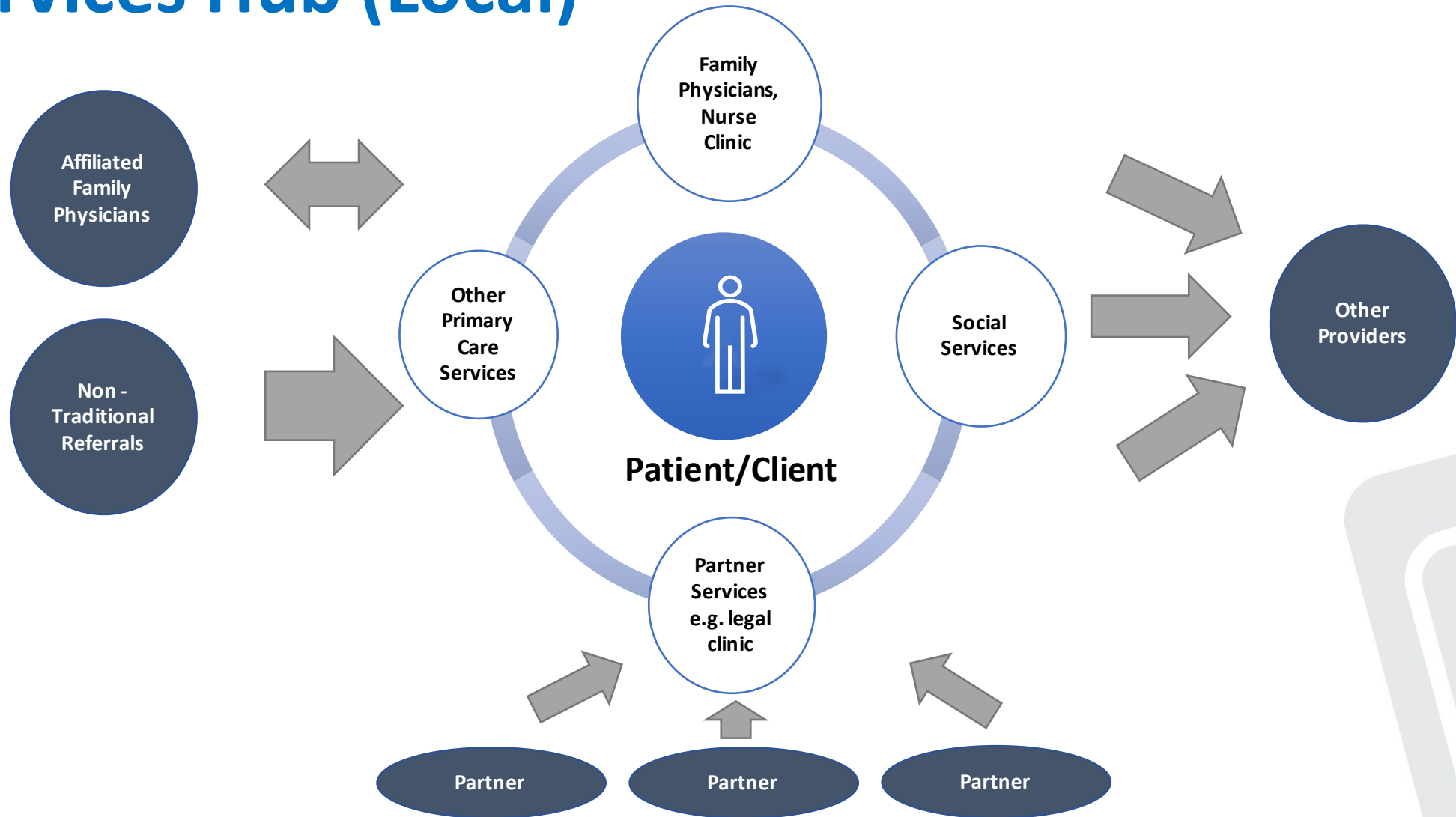


# A long journey that needs to continue
