SUBJECT: MOBILE SIGNS

### A. PURPOSE

The Region uses portable mobile signs to advertise events, promote programs and announce message alerts to the public. The Region's in-house mobile sign service will only be used to display mobile sign messages related to services provided and/or supported by the Region, including Peel Regional Police and members of Regional Council. The purpose of this policy is to establish guidelines for use, placement and maintenance of mobile signs.

This policy is delivered in accordance with the following Corporate Policies:

- G00-26 Use of Corporate Resources for Elections
- F30-02 Business Expense Accounts Members of Council

### **B. SCOPE**

The Waste Collection and Processing Section of the Region of Peel (Region) Waste Management Division will administer the In-house Mobile Sign Message Service.

This policy applies to the following:

- Delineated (approved) locations within road allowances and allocated sites in Mississauga, Brampton and Caledon where the Region can place portable mobile signs;
- Scope of service provided by the Region's Waste Management Division to other corporate departments and requesters for use and placement of mobile sign messages;
- c. Procedures for submitting requests to place mobile sign messages;
- d. Conditions and standards for placement and maintenance of portable mobile signs; and,
- e. Cost and service fees associated with the placement of mobile sign messages.

### C. POLICY

### 1. Acceptable Sign Locations

a. Portable mobile signs can only be placed on selected road allowances that have been designated by area municipalities, in accordance with their respective Sign By-laws, and any other applicable By-law as acceptable locations for the placement of portable mobile signs. Specific locations (dedicated) have been assigned by area municipalities for exclusive use by the Region for the placement of mobile signs. Mobile signs can also be placed on other locations (non-dedicated) depending on the availability of the location. The list of acceptable dedicated locations for the placement of portable mobile signs is provided in Schedule A (Region of Peel Mobile Sign Locations). Other acceptable sign locations must be approved by the local municipality. Peel staff will contact staff from the respective local municipalities to book dedicated sign locations.

### 2. Scope of Service

The Region's portable mobile sign message service is the responsibility of the Region of Peel's Waste Management Division and they are responsible for the following:

- a. Receiving and processing of mobile sign requests;
- b. Establishing priorities for mobile sign usage in accordance with section C.5 Conditions and Standards;
- c. Booking sign locations with applicable local municipality;
- d. Administering the conditions and standards for placement and maintenance of mobile signs;
- e. Handling all related inquiries and service requests; and,
- f. Allocating associated costs and service fees to users and requesters.

### 3. Submitting Service Requests

a. Submission of the request for placement of mobile signs will be forwarded electronically to ZZG-MobileSigns@peelregion.ca.

- b. The request must include the following:
  - i. Date of placement and date of removal.
  - ii. Ensure message fits in the Mobile Sign Message Template.
  - iii. In the instance of a non-dedicated mobile sign location, include a permission letter from local Municipality and proof of purchase of any required permits.

### 4. Processing Service Requests

All requests for placement of mobile signs will be forwarded to the designated contact within the Waste Management Division.

Upon receipt of request:

- a. Placement of mobile signs on dedicated locations will be identified from the list of acceptable sign locations.
- b. Mobile sign requests involving specific non-dedicated locations will be subject to the approval of the local municipality. It is the requester's responsibility to obtain approval from the local municipality prior to submitting the mobile sign request to regional staff.
- c. The message wording for the mobile signs will be drafted by the requester using the attached standard format of 5 X 14 mobile sign letter grid (Schedule B).
- d. All requests require seven days lead time to process permit requirements, prepare messaging and set up mobile signs at the identified locations. For emergencies, special arrangements can be facilitated for immediate placement of mobile signs at dedicated locations.

e. Subject to restrictions or emergencies, mobile signs will be delivered and set up within two calendar days of the requested delivery date and removed within two calendar days of the requested removal dates. The mobile sign will remain for a minimum timeframe of seven days to a maximum of 21 days.

### 5. Conditions and Standards

- a. All dedicated locations that have been assigned by area municipalities for exclusive use by the Region (Schedule A) will only be used to advertise scheduled events, promote programs and announce messages related to services provided and/or supported by the Region, including Peel Regional Police and members of Regional Council.
- b. The Region's in-house mobile sign message service is not intended to be used to promote commercial events, private functions, athletic clubs, sporting events and other activities that are not related to public services delivered by the Region.
- c. Mobile sign requirements for critical public message alerts (e.g. boil water advisory, public health and safety alerts, etc.) will take priority for placement on identified acceptable locations, followed by Waste Management messaging. All other requests are processed on a first come, first served basis.
- d. The respective Sign By-law of the area municipalities must be complied with at all times.
- e. The requestor of mobile sign shall comply with all other regional policies including "G00-26 Use of Corporate Resources for Elections" and "F30-02 Business Expense Accounts Members of Council."
- f. Exceptions to this policy, including requests for this service by anyone other than a department within the Region, Peel Police, or a member of Regional Council, may be made only upon the approval, and discretion, of the Commissioner of Public Works or designate.

## 6. Fees and Surcharges

- a. The City of Mississauga charges \$110 for a permit fee for use of all designated Mobile Sign locations within the city boundaries. This permit is required to be renewed every 21 days.
- b. There are no fees charged by Brampton or Caledon for the use of designated Mobile Sign locations.
- c. There are currently no fees or charges to Regional Department use of the In-house Mobile Sign Messaging Service.
- d. A fee of \$170.00 shall be charged for the use of a mobile sign by a Regional Councillor. Usage shall include one mobile sign for the maximum 21 day period. The charge shall be deducted from the Councillor's Expenses Account.


