Natural Hazards Planning and Risk Management

2022

- 349 permit applications, 360 planning applications received, 95% permits met delivery standards
- Lead source protection authority in the CTC Source Protection Region
- Supported Brampton first responders during February ice jam flooding

2023

- Update floodplain hazard mapping in urban areas
- Conduct road vulnerability assessments for Peel Region road network to determine flood vulnerability (for both current and future climate scenarios) and inform future disaster route planning
- Maintain and improve real-time gauge network and enhance flood forecasting models
- Continue work with municipalities on client centric and streamlining activities for plan review and permitting through training and automated work flows

Lands and Conservation Areas

2022

- Belfountain Phase I (dam, channel and heritage gardens) construction completed, and Conservation Area reopened to the public
- Pedestrian bridge replacement at Upper Credit CA; trail upgrades at Rattray Marsh

Watershed Studies and Strategies

2022

- Complete Credit River Watershed Plan Phase 1 and 2
- Complete impact assessment to support municipalities with their watershed planning needs





Funding Sources – General Levy



Budget and Forecast



2023 Budget – Business as Usual

- Maintains current program capacity
- Sustains current service levels
- Contributes to reserves
- Maintains state of good repair for assets
- Includes total compensation adjustments
- Compensation Review fully annualized – ensures CVC attracts and retains talent
- Continue to find cost savings



Efficiencies Implemented to Achieve Council Direction

- Approval by leadership team of all hiring over six months
- COLA below the rate of inflation at 2%
- CVC continues to seek and secure external funding to leverage municipal funding, especially around capital needs
- Increased revenue targets for regulation/permit Fees, nursery/planting revenue, and CA annual membership

Funding Successes

- Belfountain Phase 1 \$4M in grants (ICIP, complete 2022)
- Trails, Boardwalks and Pedestrian Bridges \$3.24M in grants leveraging \$1.18M CVC contribution (ICIP, in progress)
- \$500K for enhanced tree planting and nursery operations (NRCAN 2 Billion Trees initiative)
- Enhanced provincial funding for Source Water and WECI
- Total \$2M contribution from CVC Foundation
- Pending significant announcement for park infrastructure

Additional Pressures

- Organization-wide compensation review forthcoming in 2023
- Asset Management program to address capital pressures and long-term investment in capital infrastructure
- *Conservation Authorities Act* changes and transition period
- Belfountain Conservation Area Phase 2 (Public Realm and Visitor Centre Capital Works)
- Continued recreational infrastructure and public realm investment across numerous parks to address growth in park visitors (part of ongoing upward trend)
