Why is this work important?



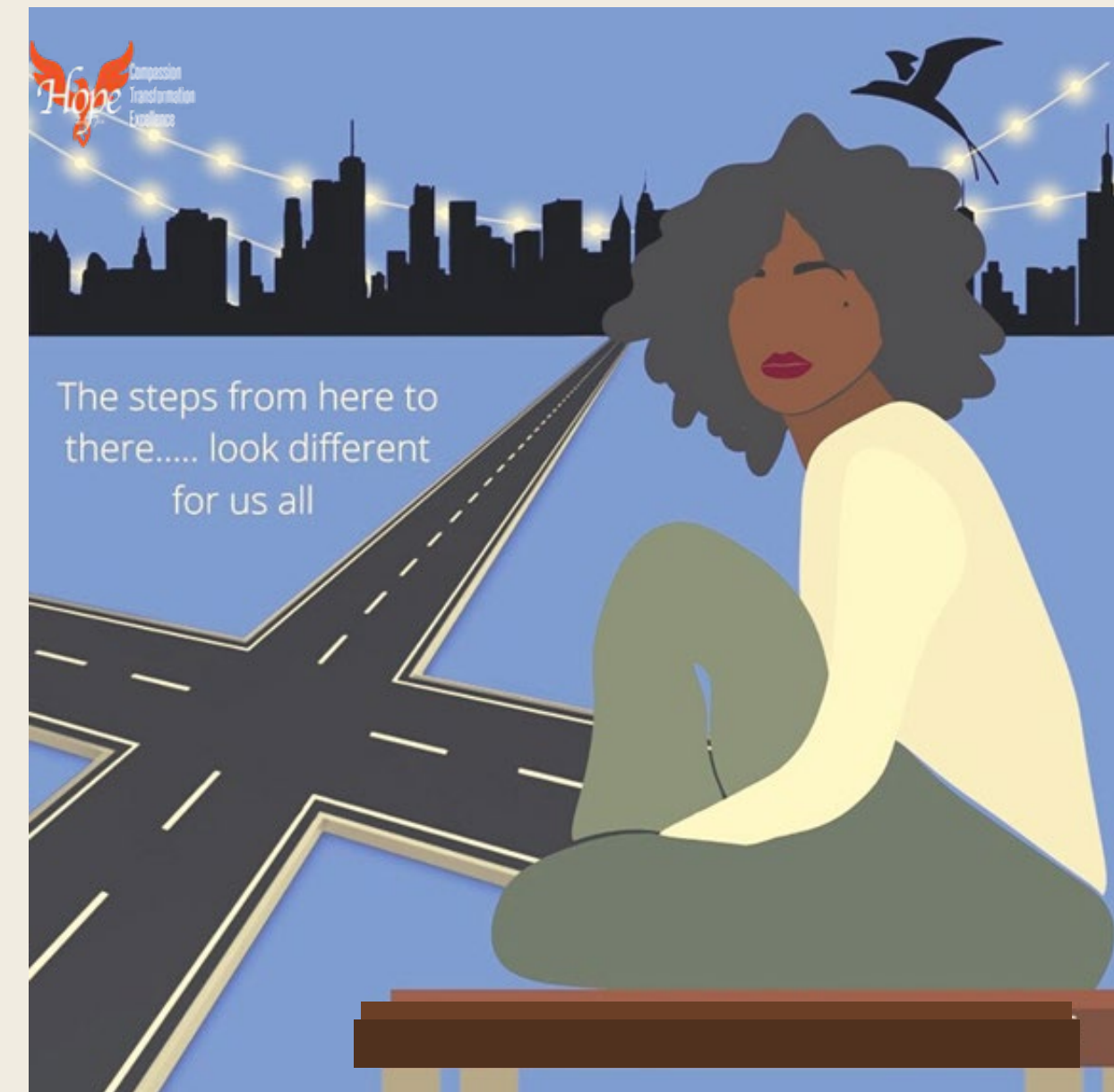
We know, not only from research, but also from being on the frontlines in our sector that the intersections to seeking support can be plentiful, complex and quite adverse.

We believe that in placing true value in the voices of those with lived experience, means applying what they teach us, to genuinely contribute to the quality of life of those in our community.

We aim to advocate for the needs of survivors in our community through first. listening to what those needs are, while acknowledging the individuality and intersections in peoples' experiences.

Every 36 hours a woman-identifying person in Canada is killed and every six days this violence against women occurs at the hands of an intimate partner.

According to the Region of Peel, Police in Peel responded to more than 17,000 incidents of family and intimate partner violence in 2021, averaging to nearly 45 disputes every day. (Region of Peel). According to Statistics Canada, though police reported incidents have risen for the fifth consecutive year, only a 19% of self-reported victims of intimate partner violence, shared that the violence they experienced was actually reported to police (Statscan). Family and Intimate partner violence fall under the umbrella of gender based violence, through concepts such as true intersectional feminism, we understand that there are still many instances of violence against women, not perpetuated by intimate partners, family or even sexual predators. The best way to increase protection for folks in our community, is to educate and equip the community itself. Action toward the goal of community safety as well as community transformation is our goal.



A Concerted Aim

How we are helping the Community Grow?

- Working with community and partner organizations to raise awareness around the collective attempts to survey and
- community needs.
Analyzing and improving access to resources, while simultaneously working to develop community based alternatives to systemic institutional involvement which has often been proven to be
- dangerous, especially for people from the BIPOC and LGBTQ2S+ communities.
Developing stable substructures enhancing the provision of supports those who require additional services based on intersectional analysis of real world factors and experiences.

A Concerted Aim

How we are helping the Community Grow?

- Listening to community and partners to set collective goals and milestones
- Using qualitative Research to address and subsequently meet the needs of the community in the most impactful ways possible
- promoting self sufficiency in community
- Developing and educating on the supports that can be put in place to respond to community needs and crisis
- Using Anti-Oppressive, Harm Reductive practices to teach community members how to initiate change in thier environment through possessing skills like de-escalation and peer counselling

The Research

The data obtained through our research will be published and made available for examination by the collective and our community as a whole

Our agency will continue to modify community trainings, resources and programming.

Working with community to aid in the development of alternatives, to the often traumatic involvement of potentially harmful institutions and the need to navigate inequitable systems.

Feminist Collective will continue working with Research Partners, and community volunteers on a number of project components.

We will conduct focus groups and interviews of survivors in our Region that have experienced GBV, and have been met with negative system responses while in search of the supports that they need.

One component of this work is conducting community-based asset mapping in order to ascertain the number of women and non binary folx in leadership positions in the charitable/not for profit sector in Peel, and develop a gender based analysis of leadership in the sector, to identify areas to address in strategic planning.

The Research

Through our community based participatory research, and partnerships with other Agencies within the social service and mental health sector, the expansion of our trained volunteer base, we continue to work to uplift community members by providing supports for sustainable community input and social change, in spaces where people feel safe and dignified.

Using data collected through asset mapping to gain understanding on representation of Women and non-binary people in our sector, qualitative research and interviews in 125 survivors, we hope to catalyze new approaches to the prevention of GBV, effectuating systems created by and for the community.

The co-design of programming and systems of upliftment for clients and community, will be constructed by the collaborative following the evaluation of data collected.



Collective Objective

- Co-creation of well-established, community driven alternatives to the prevention of GBV, equipping community with approaches to self governance through de-escalation skills, trauma informed care, harm reduction in order to establish a safer community to live in by educating and empowering the community
- Increasing the amount of GBV survivors who forward to seek healing and care after
- a traumatic experience without fear of retribution from systems of power
- Survivors of violence develop trust of community social services through reform, alternative methods of healing, and self determined care
- Service providers in Peel receive more funding and community input to care for GBV survivors, individuals experiencing mental illness, and families

Deliverables.

What do we want this project to yield?

- Survivor Engagement: A formal research publication developed by research lead, based on 125 subjects who have lived experiences of GBV in Peel.
 - Operational Planning with community to initiate ongoing community conversations that focus on
 - keeping ALL community members safe, and ensuring the community feels truly heard
 - Equipping like-minded individuals with valuable skills to support other community members.
- Providing education to the community about the realities of GBV and how violence is perpetrated through institutional processes such as victim blaming affidavits, KGB statements and criminalization of the survivor as well as how much of our community's money is being spent on these ineffective methods. Our advocacy/education campaign will also illustrate the current ways that systemic discrimination within various social institutions, combined with under-resourcing, continues to subjugate women identifying folx and their communities.

Our Team raises awareness in community on the existence and impacts GBV and other socially prevalent issues.



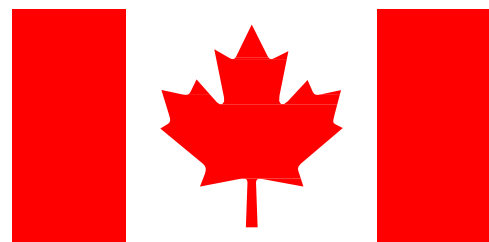
