RE: Peel Police Board Appointment

Our City's Black African and Caribbean community is a vibrant and active contributor to the cultural and economical mosaic of Brampton. It represents the second-largest group of visible minorities in the city with a growing population of more than 80,000 residents. Our Black community has been vocal about the need to increase their economic, social and cultural impact in the city. Despite this the Black Community continues to see disproportionate engagement with police and a historic under representation on the Peel police board with only one member having served who is Black.

Members of the Mayors Black Advisory have reached out requesting I write to you to encourage an equity based approach to future appointments by including members of the Black diaspora to be appointed to the board. While equity cannot be guaranteed in an elected process, it can be in a selection based process of which some of the board positions
