RECOMMENDATION ARC-12-2023

That a revised Procurement By-law, as generally described in the report of the Regional Solicitor and Commissioner of Legislative Services, as listed on the September 21, 2023 Audit and Risk Committee agenda, titled "New Procurement By-law," be presented to Regional Council for enactment.

Kristin Misurka, Director, Procurement, provided an overview of the proposed modernized Procurement By-law stating that it is reflective of current public procurement trends, inflationary pressures and continues to reflect the guiding principles of Peel's procurement processes. The Director highlighted the key changes to the proposed by-law.

Members of the Committee discussed and raised questions regarding value versus quality when assessing best value bids; local vendor preference; net zero/sustainability requirements; review of consecutive awards provided to vendors; direct negotiation provisions; whether bids are exclusive of taxes; review of order splitting for direct negotiations; and, maximum limits for direct negotiation.
