## 5.1 Peel Housing Corporation Accessibility Design Guidelines

Presentation by Jeff Tang-Kong, Program Manager, Multi-Residential Asset Manager, and Hitesh Topiwala, Manager, Infrastructure Planning and Servicing, Peel Housing Corporation

### Received

Jeff Tang-Kong, Program Manager, Multi-Residential Asset Manager presented an overview on the Accessibility Design Guidelines for the Peel Housing Corporation. The Guidelines focus on key areas within a building including common area wayfinding, visual contrast and signage, and in-suite accessible kitchen and bathroom features.

Members of the Committee discussed and raised questions regarding guidelines for low and mid-rise buildings; the process to request accessibility modifications to units, including timeline and types of retrofits; accessible unit targets; maintenance and contractors; market affordability; and housing application and waitlist timelines.

In response to questions from Members of the Committee regarding the housing application process and waitlist timeline, Lindsay Sieben, Advisor, Peel Housing Corporation undertook to provide a response directly by referring the related questions to the appropriate program area.

The following accessibility considerations were noted, including the material used at the end of stairs that could potentially pose as a trip hazard; location and number of grab bars; colour contrast in common areas; tactile warning indicators in front of the elevators; and accessibility cabinetry in kitchens, such as pull downs for upper cabinets. The Committee also suggested sharing the Accessibility Design Guidelines with the public and industry sectors.
