11.1 Town of Caledon New Employment Area Official Plan Amendment 274 – Regional Staff Review and Recommendations

- 1. That pursuant to Section 17(34) of the Planning Act, Official Plan Amendment 274 for the Town of Caledon which was adopted by Town of Caledon Council by By-law 2023-087 on October 10, 2023, be approved as modified; and
- 2. That the Town of Caledon Official Plan Amendment 274, as modified, be deemed to be in conformity with the Planning Act, consistent with the Provincial Policy Statement, and in conformity with the Growth Plan for the Greater Golden Horseshoe and the Region of Peel Official Plan; and
- 3. That the Regional Chair and the Regional Clerk be authorized to sign the Notice of Decision documents approving the Official Plan Amendment for the Town of Caledon, as modified, and attached as Appendix VII to report of the Commissioner of Public Works, listed on the November 23, 2023, Regional Council agenda titled "Town of Caledon New Employment Area Official Plan Amendment 274 Regional Staff Review and Recommendations"; and
- 4. That Appendices III, V, VI and VII to the subject report be amended to include modifications requested by the Province of Ontario as is relates to identification of the Future Highway 413 Corridor and Northwest GTA Transmission Corridor Protection Areas; and
- 5. That the subject report, be approved, as amended; and
- 6. That the notice of decision of Peel Region's approval of the Town of Caledon Official Plan Amendment 274, as modified, be given in accordance with the Planning Act; and
- 7. That a copy of the subject report be provided to the Town of Caledon, Cities of Brampton and Mississauga and the Ministry of Municipal Affairs and Housing.

The Chief Planner and Director of Planning and Development Services, advised that staff received correspondence from the Ministry of Transportation and the Ministry of Energy requesting minor modifications to a policy and mapping to be clear that corridor protection applies for both the Highway 413 Study Area and the North West Transmission Study Area, whereas before only the Highway 413 Study Area was referenced. In response to a question from Councillor Parrish,

the Chief Planner confirmed that the modifications are not contrary to the position Council has taken regarding Highway 413 and advised that Peel staff communicated with Town staff who provided the revised map.

The report recommendation was revised to address the identification of the future Highway 413 Corridor and Northwest GTA Transmission Corridor Protection Areas through revisions to Appendices III, V, VI and VII of the subject report.
