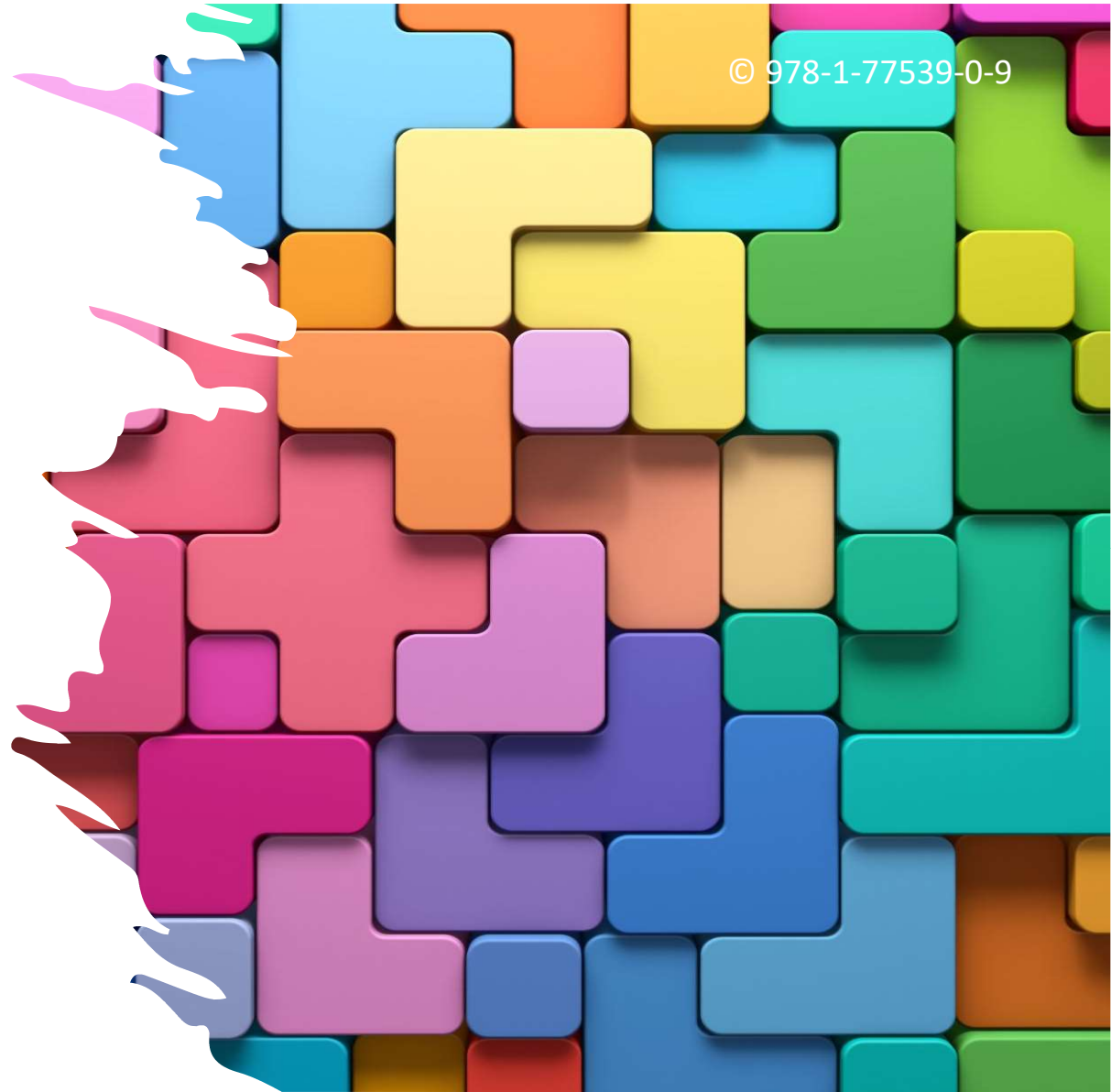

- Hx: Councillor Carolyn Parrish, 2018, along with residents and PDSB partnered to establish affordable homes on the Farmhouse property which successfully narrowed down to two bids
- However, the process was halted, due to the lack of internal provisions for an **Anti-Black Racism** division within PDSB
- Since the above, Peel Region on a whole identified the need for circular economy solutions and strategies with some regard towards public procurement (goods, services and work).
- Peel Region's involvement in CCRI (**Circular Cities & Region's Initiative**) as quoted "has an ability to take stock of the initiatives and activities currently being undertaken in all three local municipalities that are circular in nature but not marketed as circular. There's a great amount of work that we can tap into to further advance circularity"

- Let's keep the Truth and Reconciliation Act in mind and the relationship with First Nations Communities as we establish newer developments



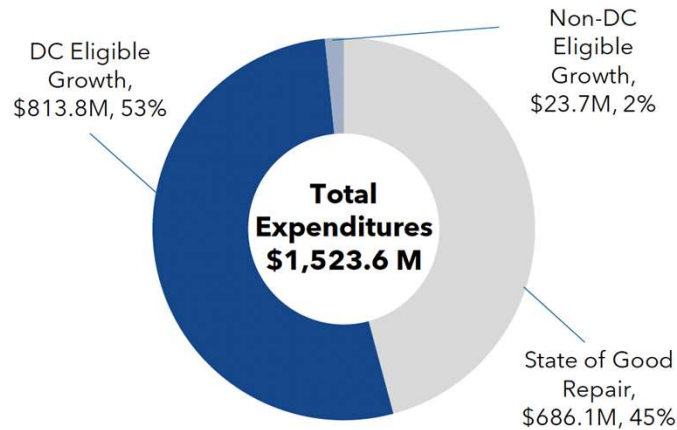

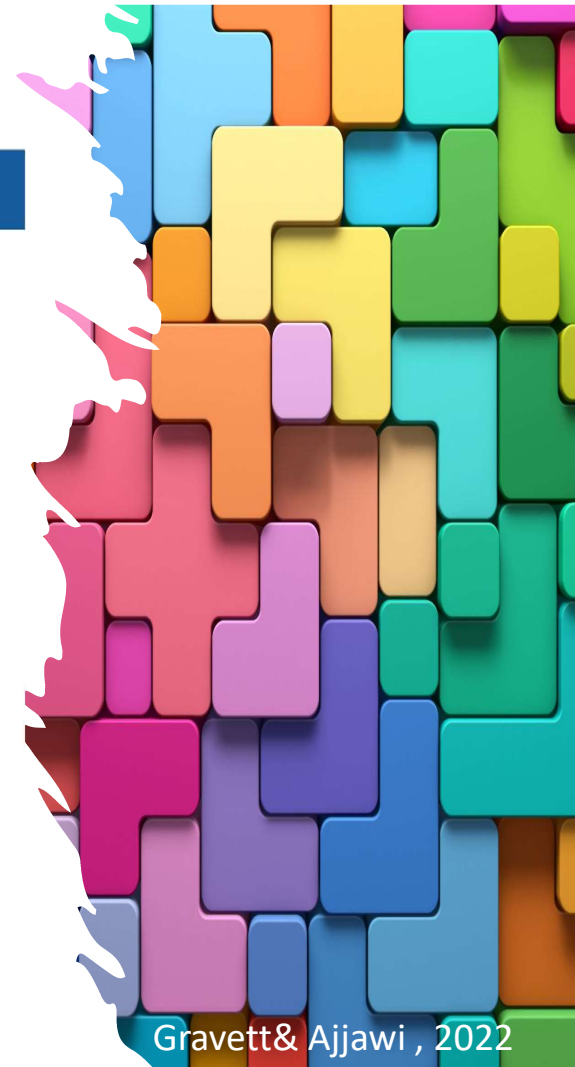
2023 10-Year Capital Plan \$1,523.6 million

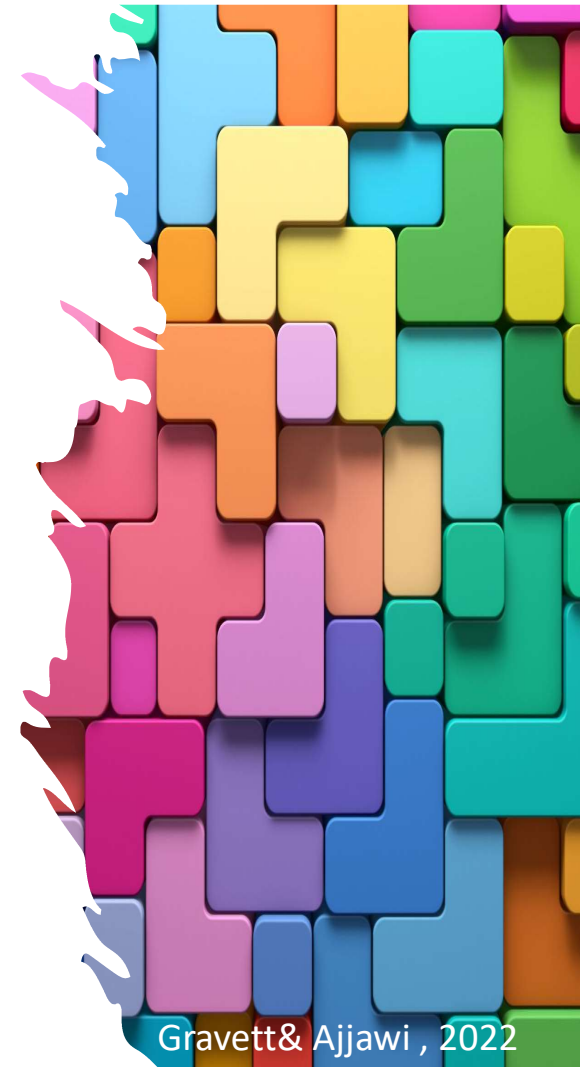

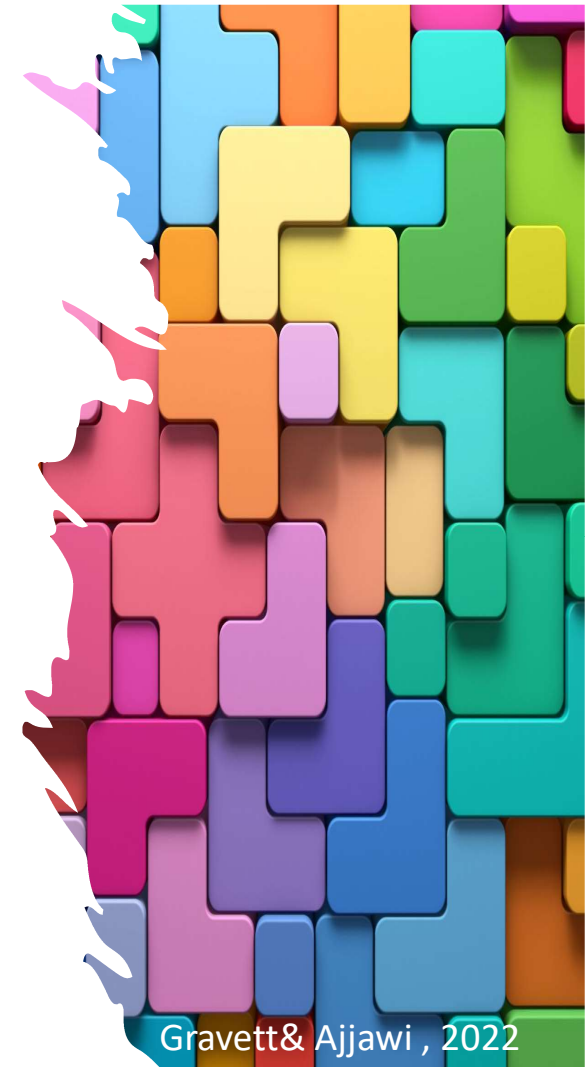

Belonging:

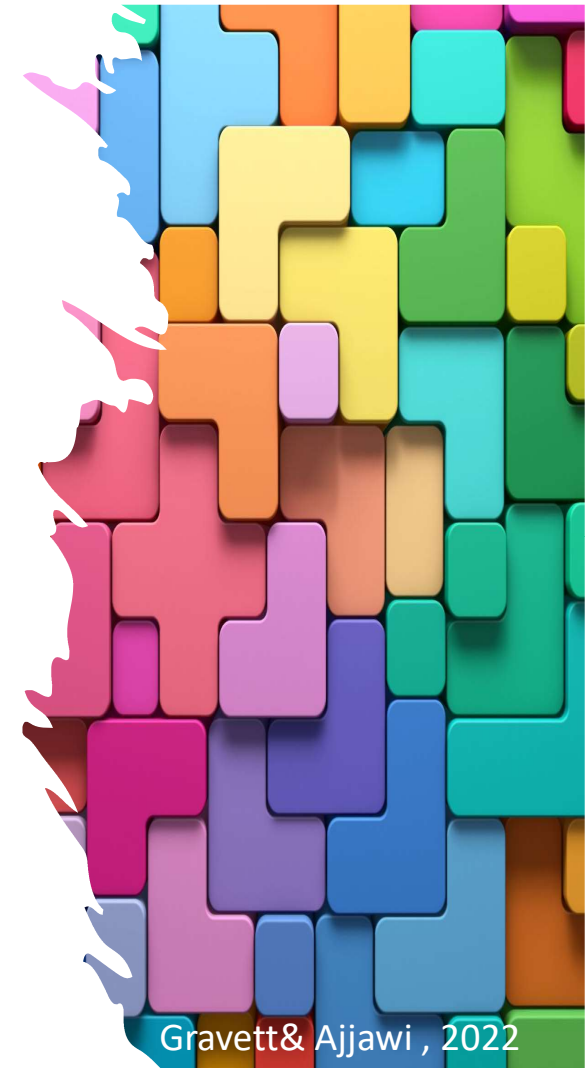
- A sense of shared and visible rights; a place, space and ability to influence Mississauga's social fabric
