2. That, once the Ward 5 Councillor seat is declared vacant, Council direct staff to proceed with the following:
 - a. Direct staff to run a by-election to fill the Ward 5 vacancy.
3. That Council directs staff to proceed with a by-election to fill the Ward 5 seat, they pass “A By-law to provide for a by-election for the Office of Councillor, Ward 5 for the City of Mississauga” at the March 20, 2024 Council meeting after the Ward 5 Councillor vacancy is declared; and
4. That the Clerk be directed to send a copy of Council’s declaration of vacancy to the Region of Peel.
