The impacted residents of **Applewood Hills & Heights** in Ward 3 and **Applewood Acres** in Ward 1 support Councillor Fonseca's motion seconded by Councillor Dasko - item 22.2 on today's agenda and further request:

1. The Region of Peel having a **rat rebate program** to residents to help in the cost of exterminating rats from their properties.
2. Council to **approve and allow for funding towards the purchase of rat traps** which would be made available to all rat affected residents for free until the rebate program is in place.
3. **All upcoming Region of Peel and Municipal Construction** projects in the Region to have **pre-baiting measures in place prior to the start of all construction projects**; and including the same requirement for **all other non Region and City private developments/construction that are approved by the Planning and Building Departments**.
4. In all three municipalities of the Region of Peel – Brampton, Caledon and Mississauga – the **Property Standards by-laws of each to include strict measures in addressing and possible outbreak and elimination of rat and or rodent infestation**.
5. **A clearly outlined time frame outlining dates** of when Region of Peel staff are to present their recommendations of the resolutions for moving forward on this matter as proposed in Councillor Fonseca's motion item 22.2.

*Impacted residents need your help in eliminating the rats from our properties, streets and communities.

*This rat infestation problem on properties was not created by the resident. For this reason the residents should not be expected to resolve this problem on their own but in partnership with the Region and Municipality.
