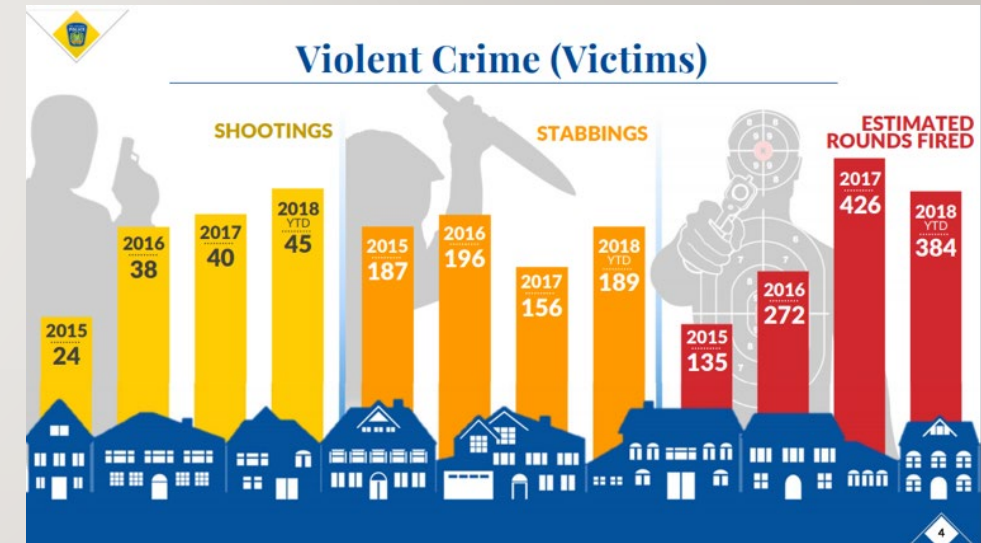

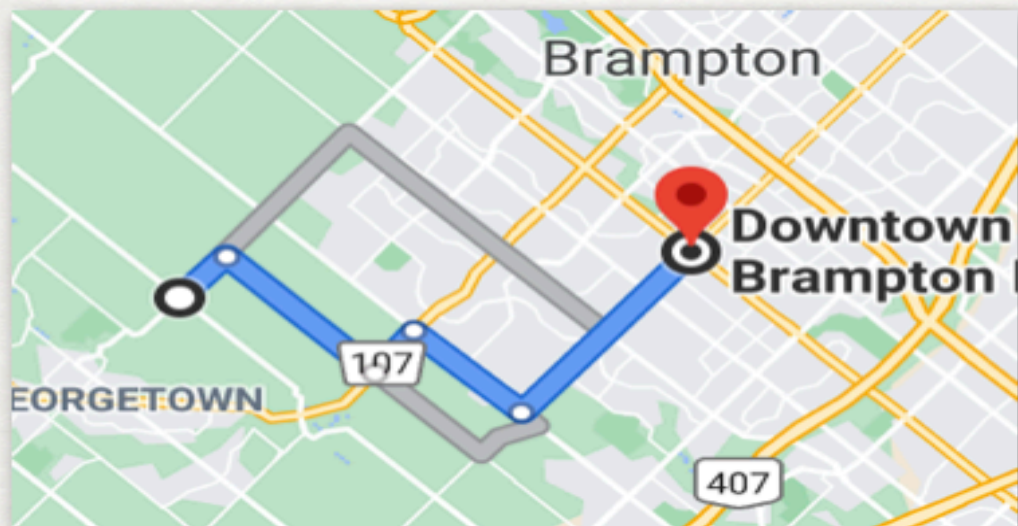
# CRIME

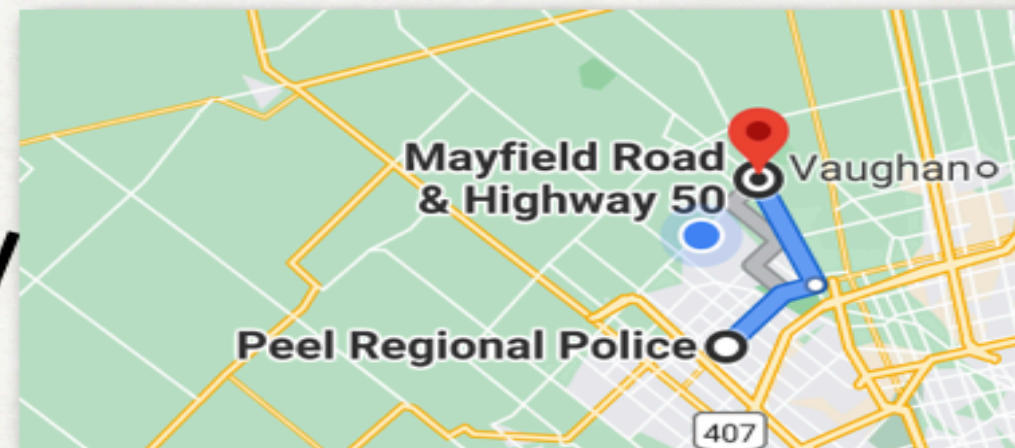
