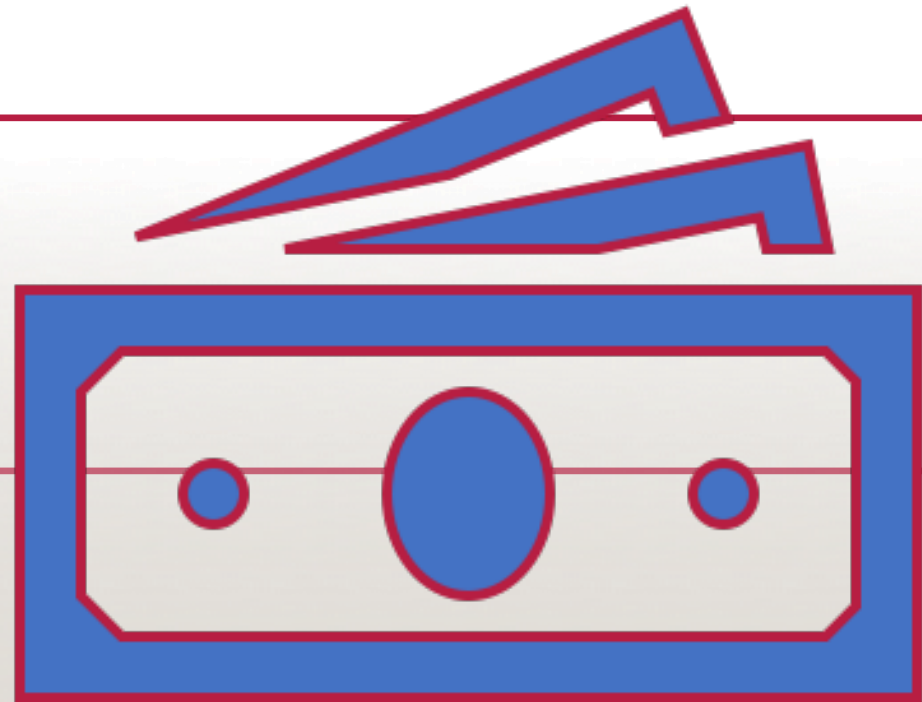
FREEZE TAXES

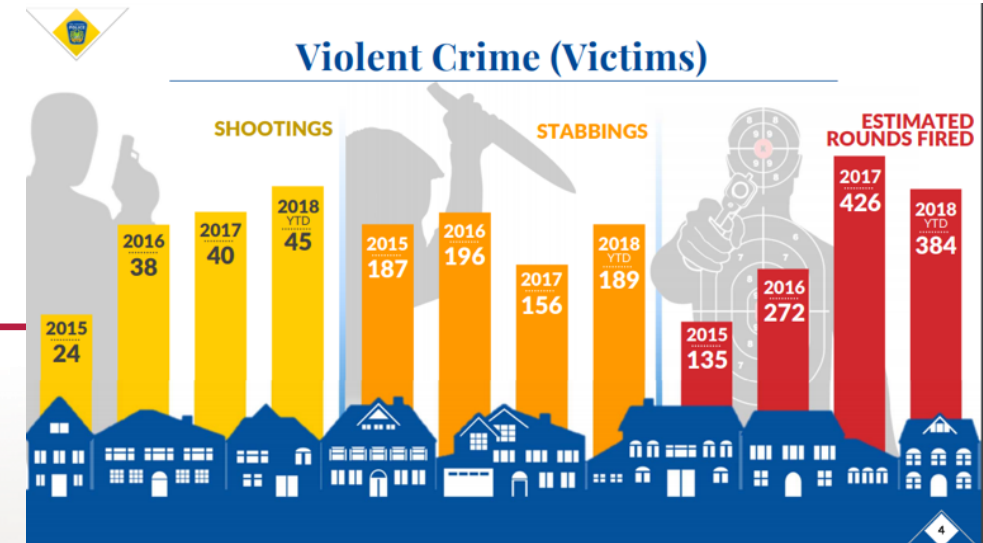

The region should provide an incentive for small business to help them through this tough time

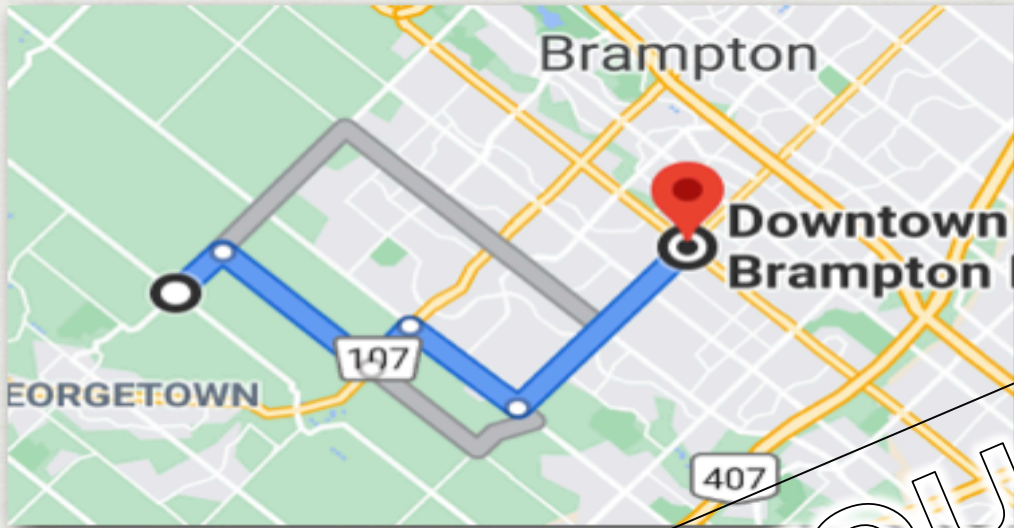

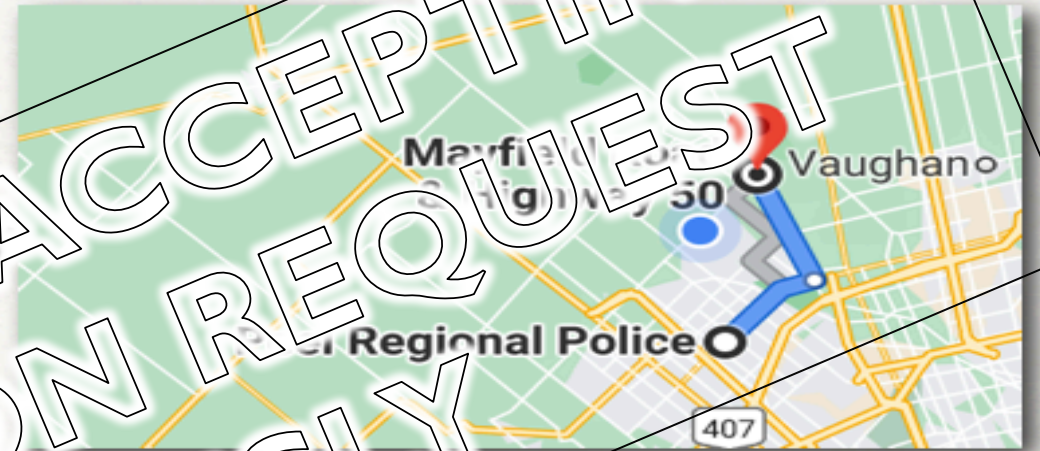
- Due to the recent increase in crime, in Peel.
